Applications are invited from eligible local candidates of Lakshadweep in the prescribed format to fill up the newly created posts of Forest Guard in the Department of Environment and Forest, U.T of Lakshadweep Administration under the direct recruitment through open competitive examination.

On verification of applications & certificates, draft checklist of eligible candidates will be published in the official website of Union Territory of Lakshadweep Administration (<a href="https://lakshadweep.gov.in">https://lakshadweep.gov.in</a>), providing opportunity to the candidates to rectify the defects if any. On finalising the final checklist, the date of physical measurement, date of endurance test and date of written test will be published in the official website with a minimum time period of 15 days. No individual communication letters will be issued in this regard. All the candidates should update themselves from the official website of Union Territory of Lakshadweep Administration about the time and date of various tests. Those candidates whose names are published in the final checklist only will be permitted to attend the physical measurement, those candidates qualify in physical measurement test only will be permitted to attend endurance test and those candidates qualify in endurance test only will be permitted to attend written test.

#### 3. Age

The candidate should be 18 to 30 years of age as on 25.01.2019. (Relaxable for SC/ST candidates, Ex-Servicemen and other special categories of person in accordance with the instructions or orders issued by Government of India from time to time).

## 4. Essential Qualification.

 Senior Secondary Examination (10+2) Passed in Science from a Government recognized Board.

- Candidates must pass written Recruitment Test consisting the subjects (a) English and General Knowledge and (b) Mathematics and Science.
- Candidates must pass physical endurance test of 25 km. walk for males and 14 km for females to be completed in 4 hours.
- Health Certificate: Medical examination of the candidate by a Medical board shall be arranged. The medical board shall issue a health certificate and also certify that the candidate is FIT to undertake strenuous outdoor work in the Department of Environment & Forest.
- Selected candidates on appointment will have to successfully complete Forest Guards training course conducted by any Forest training college sponsored by Govt. of India.

Note:

Candidates who do not possess the required essential / educational qualification as on closing date for receipt of applications are not eligible to apply for this post.

# 5. Written test:

Written test will be conducted by the agency approved by the Lakshadweep Administration. Written competitive examination test consisting of the subjects (a) English and General Knowledge and (b) Mathematics and Science of Plus-2 standard. Each subject shall consist of 100 multiple choice objective type questions carrying one mark each which will have to be answered in 2 hours duration. Candidates have to secure a minimum of 45% Marks (40% Marks for SC/ST candidate) to qualify in the written examination in each subject.

Note: In case of sufficient number of candidates are not available to fill up the vacancies the department reserves the right to relax up to five marks to fill up the vacancies.

#### 6. Selection

Selection will be made on the basis of total marks obtained in the written examination provided the candidate should have health certificate stating FIT issued by the Medical board duly constituted for this purpose.

#### 7. Validity of the result

The selection list / waiting list published will be valid for a period of one year from the date of issue of its publication for considering the candidate for the appointment if any vacancy arises within one year.

# 8. How to apply

Candidates should apply only in the prescribed format. The application form is available in the website of Lakshadweep Administration. The duly filled application form along with self attested copies of proof of age, educational qualification, community, etc should reach to Conservator of Forests, Department of Environment and Forest, U.T of Lakshadweep Administration, Kavaratti -682555 on or before the closing date and time. Application received after the closing date and time will not be considered. The department will not be responsible for any postal delay.
