4. Method of Selection:

- a. Candidates should attend walk in selections as per the above schedule and produce documents listed at point 6.
- b. The selection of GEAs will be processed based on the marks obtained in the Engineering Graduation .
- 5. General Conditions:
 - a. Candidates should produce their Original Xth / SSC Pass cum Marks memo, BE Provisional/Degree, BE Consolidated Marks memo and NATS enrolemnt proof at the time of walk in selections other wise they will not be considered for selection.
 - b. Candidates who have already undergone or currently undergoing Apprenticeship under Apprenticeship Act 1961 in any Government or PSU or Private Organisation are not eligible.
 - c. Candidates who have completed their Engineering Graduation in the year 2016 or 2017 or 2018 are ONLY eligible.
 - d. Candidates selected for training will not be allowed to withdraw from training except for reasons which are beyond their control. Before commencement of the training, the candidates will have to execute a Contract of Apprenticeship.
 - e. The engagement and training are strictly in compliance with the provision of the Apprenticeship Act 1961 and there is no obligation for employment of Apprentices on completion of their training.
 - f. The Apprentice after completion of the training shall have no right to claim any employment in ECIL.

- g. ECIL being highly protected establishment, Apprentices will be engaged only after submission of Character /Conduct certificate from Engineering college and two character certificates attested by two different Gazatted officers. Selected candidates have to submit these certificates at the time of joining.
- h. A physical fitness certificate from a Civil Assistant Surgeon should be produced by the selected candidate at the time of joining.
