Candidates who have not acquired but will acquire the educational qualification and acquire documentary evidence

b) The candidates will be required to furnish at least 60 days duration Basic computer Training Certificate from a recognized computer training institute before issuance of appointment letter. Computer Training Certificates from Central Government/State Government/University/Boards etc will also be acceptable for this purpose. This requirement of Basic Computer Knowledge Certificate shall be relaxable in cases where a candidate has studied computer as a subject in matriculation or Class-XII or Higher educational qualification and in such cases a separate certificate will not be insisted upon.

11. Sports Qualification (Eligibility Criteria):

The candidates with the following qualifications shall be considered meritorious for the purpose of recruitment under sports quota -

- a) Sportsmen who have represented a State or the country in the National or International competition in the sports/games shown above.
- b) Sportsmen who have represented their university in the inter university tournaments conducted by the Inter-University Sports Board in the sports/games shown above.
 - c) Sportsmen who have represented the state schools team in the National Sports/Games for schools conducted by the All India School Games Federation in the sports/games shown above.
 - d) Sportsmen who have been awarded National Awards in Physical Efficiency under the National Physical Efficiency Drive.

13. Application Fee:-

- All the Applicants have to pay an application fee of Rs 200/- (Rupees Two hundred only) in form of Indian Postal Order (IPO) only, in favour of "Chief Postmaster General, BIHAR Circle" payable at the Post Office "PATNA GPO, PATNA". Original Indian Postal Order must be enclosed with the duly filled application form.
- Application fee of Rs.200/- (Rs. Two Hundred Only) may also be deposited in Unclassified Receipt (UCR) in any post office of Bihar. Original receipt must be enclosed with the duly filled application form.

Note: Fee once paid shall not be refunded under any circumstances.

Exam Fee: Only the Applicants who are called for field trials will have to pay an
examination fee of Rs. 400/- (Rs. Four Hundred only) Women/SC/ST candidates are
exempted from payment of exam fee over and above fees.

14. Method of Selection:

Selection of candidates will be made on the educational and sports qualification subject to fulfillment of other prescribed conditions.

The main aim to recruit Outstanding Sportspersons is to prepare a best team of sportspersons, which may bring laurels to the circle in All India and other competitions apart from their best performance in official duty. In view, the most suitable and fit candidates will be considered. Selected candidates will have compulsory participation in the circle team during All India Postal Tournaments for specified years by the department.

- i. First preference to those candidates who have represented the country in an international Competition with the Clearance of the Department of Youth Affairs & Sports.
- ii. Next preference will be given to those who have represented a State/UT in the senior or Junior Level National Championships organized by the National Sports Federation recognized by Department of Youth Affairs and Sports or National Games organized by Indian Olympics Association and have won medals or positions up to 3rd place. Between the candidates participating in Senior and Junior National Championships/Games, the candidates having participated and won medal in Senior National Championship should be given preference.
- iii. Next preference will be given to those, who have represented a University in an Inter-University competition conducted by Association of Indian Universities/Inter University Sports board and have won medals or positions up to 3rd place in finals.
- iv. Next preference will be given to those, who have represented the State Schools in the national Sports/Games for Schools conducted by the All India School Games Federation and have won medals or position up to 3rd place.

v. Next preference will be given to those, who have been awarded National Award in Physical Efficiency under National Physical Efficiency Drive.

vi. Next preference will be given to those, who represented a State/Union Territory/University/State School Teams at the level mentioned in categories (ii) to (iv) but could not win a medal or position, in the same order of preference.

vii. Trial will be done if needed and wherever needed.

Note 1: Only in the event of tie those who have secured a higher position or won more than one medal may be given the preference, or as per the prevailing rules.

Note 2: Participation in individual and team event/item may be given the same preference.

Note 3: No preference may be given for winning more than one medal / position.

Note 4: In case of any doubt about the status of tournament, the matter will be decided by the Department of Personnel & Training in consultation with Department of Sports and Youth Affairs.

Note 5: Decision of competent authority i.e. Chief Postmaster General, Bihar Circle will be binding on all.

15. Disqualification:

- a) No person who has entered into or contracted a marriage with a person having spouse living; or
- b) No person who having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to service. Provided that Central government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule. Information/misrepresentation of facts/unsigned Application Form/without photographs/without prescribed application fee/not accompanied by self attested copies of required certificates/received after due date. No correspondence will be done in this regard.

c) If it is proved at any stage that the candidate has forwarded incorrect or false information in this regard.

d) Application wrongly addressed or received after due date will be summarily rejected, whatever may be the reason for delay. No intimation will be sent in this regard.

e) The applications should be sent through Speed Post/Registered Post only.

f) Candidate applying for more than one game/event shall submit separate application form with complete documents for each game/event in separate envelope/cover and all such envelopes/covers are to be sent through Speed Post/Registered Post separately.



- g) One envelope should contain application form of one candidate for single sports discipline only. Applications forms of any candidate for more than one sports discipline submitted in a single envelope/cover or applications form of more than one candidate received in a single envelope/cover will be summarily rejected. In case more than one application forms (of single candidate or multiple candidates) are received in any single envelope, all such application forms will be rejected.
- h) The selected candidate may be appointed against any of the identified vacancies as mentioned in Annexure-1.
- i) Once appointed, request for transfer will be entertained as per existing rule.
