5. In addition to the usual pay & allowances, deputation allowance and Risk and Hardship Allowances will be paid as per admissibility according to the Government's instruction from time to time.

6. Indian Air Force Officers joining BSF Air Wing on deputation will be under the administrative and functional control of DG BSF and will continue to be subject to the Air Force Act and Rules for disciplinary purpose as per the Agreed Terms & Conditions signed between MHA and MoD. 
