

## ENGAGEMENT OF INSPECTORS ON CONTRACTUAL BASIS IN CBI

Looking for retired and serving Police Officers of the rank of Inspector and above for appointment as Inspector on contract for one (1) year or till the filling up of these vacancies either by Promotion or by Deputation, whichever is earlier at a consolidated remuneration not exceeding Rs.40,000/- per month. The candidate should be a graduate from a recognized university. The person engaged shall have no right to claim regularization/absorption in the organization after the expiry of period of contract.

2. The retired officers of the Central/ State Police Forces of the rank of Inspector or above with 10 years of experience in investigation and facilitating/assisting in prosecution of criminal cases in the court of Law are eligible for appointment to the above mentioned post. The candidate will be on whole time appointment and will have no right to undertake part time private employment during the period of contract. The Inspectors appointed on contract will be utilized by HoZ/HoB in best interest of CBI.
