QUALIFICATION AND EXPERIENCE (For Civil Wing):

Sr.No.1: General Manager (Civil), No. of posts – 2.

Candidate must be B.E/B.Tech (Civil) engineering graduate having more than 20 years of Post Qualification experience in construction of large infra project of planning & execution in Viaducts, Bridges, Multi-Stored Buildings, Workshop Sheds etc. Candidates having working experience in Metro Rail civil engineering projects will be preferred. The candidates will be responsible for supervision and monitoring of Construction works, planning, design and interface with Government Agencies, etc.

Candidate must be familiar with management of contracts relating to the large infrastructure projects. Quality Control & Assurance System in civil construction, Safety Implementation, Programme Monitoring, IS / International Codes for construction of civil underground structures is desirable.

Candidates having relevant experience in State or Central PSU / Board / Organization of Government / Metro Rail Organization having implemented Metro Rail Project will be given preference.

For Track: Candidate must be a B.E / B. Tech (Civil) engineering graduate having minimum 18 years of Post Qualification experience in detailed track design and construction of Metro Rail / Railway track / track components procurement / planning construction and should be well versed with long welded rail (LWR) design and specifications. Experience should be in Ballast less track. Shall be incharge of all track related works and will also be responsible for track alignment, design & planning and track construction, maintenance and procurement. Candidate should have experience and knowledge of inter-face with Metro Railway related disciplines such as signaling, traction and rolling stock, etc.

Tech (Civil) engineering graduate having minimum 10 years of Post Qualification experience in large infra project execution environment, out of which 4 years' experience in construction of Viaducts, Bridges, Multi-Stored Buildings, Workshop Sheds etc. Candidates having working in Metro Rail Viaduct construction with experience of supervising Segment Casting Yard work, erection of Launching Girder for segment launching, pile foundation works etc, will be preferred. Responsible for supervision and monitoring of Construction works as per DPR.

Sr. No. 5: Manager (Civil) - No. of posts - 2.

Candidate must be a B.E / B. Candidate must be a Diploma in Civil Engineering (3 years diploma) from recognized University having minimum 3 years of post qualification experience in Survey works of Civil engineering and should have handled all latest equipment's independently and carried out survey works in large infrastructure projects.

Sr.No.1: General Manager (Operation), No. of posts – 1.

Candidate must be a graduate from University / Institute recognized by the Govt. of India or a State Government, having minimum overall 20 years of post qualification experience in Train Operation of Railway / Metro, out of which about 5 years' experience in executive / managerial cadre of Metro Rail Operations is essential.

Candidate should have worked in main line and depot operations of trains, Stations and OCC. Experience in CMRS certification and the commissioning of new line is preferable. Also, preference will be given to candidates having experience in operations of a Metro Railway System.

<u>Sr.No.2: Deputy General Manager (Operation), No. of posts – 1.</u>

Candidate must be a graduate from University / Institute recognized by the Govt. of India or a State Government, having minimum overall 10 years of post qualification experience in Train Operation of Railway / Metro, out of which about 3 years' in executive / managerial cadre experience of Metro Rail Operations is essential.

Candidate should have worked in main line and depot operations of trains, Stations and OCC. Experience in CMRS certification and the commissioning of new line is preferable. Also, preference will be given to candidates having experience in operations of a Metro Railway System.

<u>Sr.No.3: Deputy General Manager (Signaling), No. of posts – 2.</u>

Candidate must be a BE /B.Tech (Electronics/ Electronics and Communication) engineering graduate from University / Institute recognized by the Govt. of India or a State Government, having minimum 10 years of experience in planning, design, preparation of technical specification, administration of contracts, installation, testing and commissioning of signaling and telecommunication works in a Metro Rail System / Main Line Railway System.

Preference will be given to candidates having experience in construction, installation, testing and commissioning of Signaling and associated telecommunication works on a Metro Railway System

<u>Sr.No.4: Deputy General Manager (Telecom), No. of posts – 2.</u>

Candidate must be B.E/ B.Tech (Electronics / Electronics & Communications/ Computer Science/ Electrical) engineering graduate having minimum 10 years post qualification experience in installation / testing / commissioning / operations of Telecommunication Systems in any Metro Rail/ LRT / Suburban Rail/ Railway Systems / Airports etc. is essential. Candidates with Metro Rail Project experience will be preferred. Experience in CMRS certification and the commissioning of new line is preferable. Also, preference will be given to candidates having experience in operations of a Metro Railway System.

<u>Sr.No.5: Deputy General Manager (Traction), No. of posts – 2.</u>

Candidate must be a B.E / B. Tech (Electrical)/ (Electrical & Electronics) engineering graduate with minimum 10 years experience in planning, design, preparation of technical specification, administration of contracts, installation, testing, commissioning and statutory approvals of traction power works including receiving sub-stations, traction sub-station, auxiliary sub-station and power distribution works in construction projects of railways / metros/ other PSUs/ private sector dealing with electric traction system. Also candidate should be conversant with international competitive bidding process, computerized environment working and latest technologies in electric traction system etc. for underground/ elevated metro/rail projects in urban & suburban environment including consultancy works related to urban rail projects. Candidates with experience of working in modern urban metro rail systems with 750V DC third rail traction will be given preference.

Sr.No.6: Deputy General Manager (E&M), No. of posts – 2.

Candidate must be a B.E / B. Tech (Electrical / Electrical & Electronics / Mechanical) engineering graduate having minimum 10 years of post qualification relevant experience of E&M works in elevated Metro rail projects.

Shall be responsible for Co-ordination, supervision and DDC in connection with Design / Specification, installations, testing, commissioning and site supervision of LT panels, DG sets, LT cables & cable trays, EOT cranes & compressor systems for workshops, BMS and Access control system, VRF/VRV air-conditioning system, LV distribution, Electrification of Building, Earth mat and Earth pits, Fire pumps and plumbing pumps, Fire hydrant, Sprinkler and Fire Detection and Alarm, Interfacing with other system Dept. Review of tender documents, GFC drawings etc. submitted by DDC.

Sr.No.7: Legal Assistant (Equivalent to Asst.Manager cadre), No. of posts - 1.

Candidate must be a full time graduate degree with three years LLB reputed university having minimum 7 to 9 years of experience in prescribed post qualification in the following areas: Arbitration, Industrial Law, Labour Laws, Contract Agreements, Administrative Law & Company Law.

Candidate should be proficient in practices & procedures of Civils Courts, Tribunals, Arbitration Proceedings, submission of pleading and execution of decrees / awards. Drafting plaint, written statement, affidavits and various types of petitions to be filed in the court / tribunals. Also responsible for Drafting and scrutiny of various documents such as agreements like JV Agreements, service and security bonds, guarantee bonds and sale deeds etc. Preference will be given to persons having registration in Gujarat Bar Council with 10 years seniority and have gujarati language proficiency.

1. ON CONTRACT

2. CONTRACT APPOINTMENT

- 1. The Contract Appointment will be initially for 3 years to 5 years on extendable basis.
- 2. The contract of appointment may be terminated by either side by giving 30 days (up-to Assistant Manager Cadre) or 90 days (Manager & above Cadre) notice or by paying the contractual remuneration / salary in lieu of notice period, if the circumstances so warrant.

3. CONDITIONS

- Candidates who have appeared for interviews conducted by GMRC for the above said posts on an earlier occasion need not send their applications again unless there is a change in the eligibility criteria.
- 2. Prescribed qualifications are the minimum requirements and mere possession of the same does not entitle candidates to be called for interview.
- 3. The experience is post qualification and the minimum required. Mere possession of minimum experience does not confer any right for interview / selection.
- 4. Any canvassing by or on behalf of the candidates or to bring political or other outside influence with regard to selection/appointment shall be a disqualification.
