2. CONTRACT PERIOD, AMOUNT AND OTHER EXPENSES;

The candidate shall be appointed on Contract basis for a period of one year and may be renewed at Bank's sole discretion in terms of extant policies and rules.

3. CONTRACT AMOUNT AND OTHER TRAVELLING EXPENSES;

The contract amount shall be paid as the last pay and allowances drawn by the officer less the initial amount of pension fixed before commutation plus relief etc. payable thereon OR Rs. 15,000/- per month, which ever is lower. Further a lump sum amount of Rs.500/- per month shall be paid towards mobile, conveyance etc.

However, the condition of "Last Pay &Allowance drawn by the Officer less the initial amount of pension fixed before commutation plus relief etc" will be applicable only to the pension opted retired bank official of a Nationalised Bank and in case of non-pensioner, the candidate will be eligible only for Rs.15,000/ per month together with limp sum amount of Rs.500/- towards Mobile, Conveyance etc.Please note that no other benefits or charges shall accrue or be payable.

Reimbursement of TA/DA for traveling as per requirement of the post shall be made as per the revised rate of Rs.300/- per day and travelling expenses to be paid on actual basis.No Diem allowances/reimbursement shall be payable where vehicle is provided..
