Qualification and Experience:

Post No.1(Cat-1): A First class Engineering Degree in Electronics and Communication / Electrical & Electronics / Electronics & Instrumentation with minimum 60% marks in aggregate from any recognized Institution/University with minimum 01 year post qualification experience in the field of installation, commissioning, supervision of field activities related to security system like CCTV,ACS,FAS etc.

Post No.1(Cat-2: A First class Engineering Degree in Electronics and Instrumentation / Electronics and Communication / Electronics with minimum 60% marks in aggregate from any recognized Institution/University with minimum one

year post qualification experience in the field of SCADA/Data Acquisition Systems. Candidate having exposure in PLCs will be preferred.

<u>Post No.1(Cat-3):</u> A First class Engineering Degree in Electronics and Communication with minimum 60% marks in aggregate from any recognized Institution/University with minimum 01 year post qualification industrial experience.

Post No.2: Should have passed ITI (2 years duration) in the trades of Electrical / Electronics / Instrumentation. Should have minimum 01 year post qualification experience in the field of installation & testing of security systems.
