Corrigendum

In partial modification of Advertisement No. 2 (2) 2016 dated 29.09.2016 and followed by corrigendum dated 22.06.2017 published in various newspapers vide which the applications were invited for 03 posts (Gen-02, SC of Hry.-01) of Senior Dental Surgeon Class-I in Health Department, Haryana.

The Government vide its letter no. 25/55/2018-2HB-II dated 26.09.2018 has considered the matter with a view that after issuance of advertisement in the year 2017 many Dental Surgeons working in Govt. hospitals have become eligible and the Govt. has requested the Commission for inviting applications from such candidates. Hence this corrigendum is being issued for the information of the eligible candidates that the candidates who had not applied earlier can now apply for the above posts through online mode from 18.02.2019 to 25.02.2019 upto 5.00 P.M and application fees can be deposited through online mode only, using Net Banking or Debit Card/ Credit Card upto 24:00 hrs. (midnight) of closing date i.e. 25.02.2019. Closing date for receiving printed application forms alongwith supporting documents in Commission's office is 05.03.2019 up to 05:00 PM. (Closing date for receiving printed application forms from the applicants belonging to Forward Remote Areas i.e. States/ Union Territories of North-East Region, Lakshadweep, Andaman and Nicobar Islands, Sikkim, Ladakh Region of Jammu & Kashmir and Pangi Sub-Division of Himachal Pradesh is 11.03.2019 upto 5:00 P.M).

However, the candidates who had applied earlier in response to Advertisement No. 2(2) 2016 published on 29.09.2016 and corrigendum dated 22.06.2017 need not to apply again as their previous applications will be considered, if otherwise found eligible. The age, will be determined as on 01.01.2019 and qualification, Experience & other eligibility conditions of all the candidates will be determined as on 25.02.2019 (Closing date).


Note:-

- (i) It is also clarified that the candidates who had made online application earlier in response to the advertisement and generated the challan but failed to deposit the fees within stipulated period are required to apply afresh. The commission will not be responsible for any lapse or delay on the part of the candidates or the postal authorities.
- (ii) Candidates who have already submitted the hard copy against Advt. No. 2(2) 2016 published on 29.09.2016 and corrigendum dated 22.06.2017 need not to submit hard copy again as their previous application forms shall be considered. However, if any candidates who had applied earlier and thereafter he/she had acquired higher qualification or gained further experience, upto the last date of this corrigendum (i.e.25.02.2019) then only such qualification & experience will also be considered and they may forward the documents supporting their claims upto the closing date of submission of hard copies of online applications i.e. 05.03.2019 and 11.03.2019 (only for remote areas persons) upto 05:00 P.M.
