**Sub:- FILLING UP OF GROUP 'B' & 'C' POSTS NON-GAZETTED,**  
**NON MINISTERIAL (COMBATISED POST) ON**  
**DEPUTATION BASIS IN BSF ENGG SETUP AND NDRF BNS**

It has been proposed to fill up following Gropu 'B' & 'C' posts in BSF Engineering Set-up as well as NDRF Bns which is Non-Gazetted, Non-Ministerial (Combatised) posts for a period of as mentioned against each. The eligibility conditions are as under:-
