Sub:- Recruitment of CT(GD) through remusteration for the year 2018-19.

Applications are invited from serving (Male & Female) Combatised CTs(Tradesmen i.e. Tailor, Cobbler, Cook, Barber, Washerman, Safaiwala, Gardner, Water Carrier and Waiter) and CT(Orderlies) of SSB to fill up 290 vacancies of Constable (General Duty) through remusteration for the year 2018-19 as per details given below:-

Note:-

- i) Vacancies are subject to change and may increase or decrease without any notice.
- ii) DG, SSB reserves the right to cancel/ postpone the above recruitment without assigning any reason.
- 2. <u>Eligibility criteria to apply for the post</u>:-CTs (Tradesmen and Orderlies) who fulfill the following conditions are eligible for CT(GD) through remusteration:
  - a) Have a minimum 3 years of regular service in SSB.
  - b) Have a minimum educational qualification of Matric or equivalent from a recognized board or institute.
  - c) Have medical category SHAPE-I.
  - d) Have a clean service record in the preceding 3 years of service.
  - e) APAR grading for preceding 3 years (i.e. 2015-16, 2016-17 & 2017-18) should not below "Good" (not below 04 numbers in APAR).
  - f) The <u>crucial</u> date to determine the completion of 3 years regular service as CTs (Tradesmen & Orderlies) in the force will be 1<sup>st</sup> January, 2019.
  - g) The cut off date for determining the eligibility criteria will be 01/01/2019 repeat 1<sup>st</sup> January, 2019.
- 3. <u>Age limit</u>:- Upper age limit for appearing in recruitment for the post of CT (GD) through remusteration is below 35 years for General/UR category candidates. However, upper age limit shall be relaxable by 05 years only for the SC/ST candidates.

<u>Note:-</u>a) A candidate not meeting the minimum height requirement will be rejected from recruitment process.

- b) Candidates who intend to avail relaxation in height measurement will have to submit certificate from concerned issuing District Authorities in original for justifying their claim. If, he/ she is not in position to submit the same, his/her candidature for the post shall be rejected straightaway. No appeal in this regard will be entertained by SSB at later stage and candidate himself / herself will be responsible for this.
- c) Criteria for relaxations are subject to instructions of Government of India.

- d) Candidates declared disqualified in height measurement have a right to prefer an appeal to the appellate authority for re-measurement of height. The appeal of the candidate shall be disposed off on the same day by the appellate authority.
- (ii) <u>Documentation</u>:- The candidates declared qualified on height parameters, will have to go through documentation process, in which candidates will have to produce all original documents/ certificates, the details of which he/she has given in the application form. Failing which the candidature of candidate will be rejected straightaway. No appeal on rejection during documentation process will be entertained by SSB at later stage.
- (iii) <u>Physical Efficiency Test (PET):-</u> The candidates found eligible in documentation process will have to undergo Physical Efficiency Test (PET) followed by biometric identification as per details given below:
  - a) For Male: 5 Kms race to be completed within 24 minutes.
  - b) For Female: 1.6 Kms race to be completed within 8.30 minutes.
  - c) For Ladhakh region (Male):- 1 mile race to be completed within 6.30 minutes.
  - d) For Ladhakh region (Female):- 800 meters to be completed within 4 minutes.

### Note:-

- Pregnancy at the time of PET will be considered a disqualification and pregnant female candidates shall be rejected at this stage.
- PET shall be mandatory but will only be qualifying in nature and will not carry any marks.
- Department will not be held responsible for any kind of injury, if sustained during PET.
- (iv) <u>Measurement of Chest and Weight:</u> The candidates declared qualify in Physical Efficiency Test (Race) will have to undergo chest and weight measurement as per details given below:-

<u>Note:-</u>1. A candidate not meeting the minimum chest measurement /requirement will be rejected from recruitment process. Criteria for relaxations are subject to instructions of Government of India.

2. Candidate who intends to avail relaxation in chest measurement will have to submit certificate from the concerned District Authorities in original for justifying his/her claim. If, he/ she is not in position to submit the same, his/her candidature for the post shall be rejected straightaway. No appeal in this regard will be entertained by SSB at later stage and candidate himself / herself will be responsible for this.

3. Candidates declared disqualified in chest measurement have a right to prefer an appeal to the appellate authority for re-measurement of chest. The appeals of the candidates shall be disposed off on the same day by the appellate authority.

(b) Weight:- Weight of the candidate should be proportionate to height and age as per details given below. Weight will not be a criteria for disqualification at the time of Physical Standard Test (i.e. chest and weight measurement). However, the overweight/ underweight candidates will be disqualified at the time of Detailed Medical Examination based on weight and age on the day of Detailed Medical Examination and the height as measured during height measurement.

- The body weights given in the chart are corresponding to only certain height (in cms) on even numbers only. In respect of heights in between, the principle of 'Average' will be utilized for calculating body weights.
- In doubtful cases of overweight, the assessment is to be made on the basis of BMI.
- (v) Written Examination:- The candidates who qualify in the PET. PST and Documentation will have to appear in the written examination. The written examination will be of 2 (two) hours and will of 100 marks consisting 100 multiple objective type question OMR based focusing on General Awareness, General Knowledge, Knowledge of elementary mathematics. analytical aptitude and ability to observe and distinguish patterns and to test the basic knowledge of the candidates in English/ Hindi. The questions paper will be bilingual i.e. in English or in Hindi.

# Minimum qualifying marks for written examination will be:-

- 35 % for General/UR category candidates.
- 33 % for SC and ST category candidates.
- (vi) Detailed Medical Examination (DME):- Detailed Medical Examination will be conducted of only those candidates who will score above the cut-off marks in the written test. Detailed Medical Examination will be conducted as per Revised Medical Guidelines issued by the MHA vide OM No.A.VI-I/2014/2014-Rectt(SSB) dated 20.05.2015.



(vii) REVIEW MEDICAL EXAMINATION (RME):- If a candidate is declared unfit in the Detailed Medical Examination, the grounds for rejection will be communicated to him/her by the Chairman Recruitment Board. If the rejected candidate is not satisfied with the findings of the Medical Officer, he/she will obtain Form-1, 2 & 3 from the Chairman of Recruitment Board, to prefer an appeal for RME within 15(fifteen) days from the date of issue of communication, in which the findings of the Medical Officers is communicated to him/her. The appeal for RME, should necessarily contain the following: (a) RME fee of Rs.25/- (Rupees Twenty Five only) non-refundable, through a Bank Draft payable in favour of concerned authority as intimated by Chairman Recruitment Board (b) Appeal Forms-1, 2 & 3 issued by the DME Board duly completed in all respect (c) One self addressed envelope with Rs.25/-(Rupees twenty five only) postage stamp duly affixed on it. Fitness certificate other than Form-3 (provided by the Chairman of Recruitment Board to the Candidate) will not be considered for Review Medical Examination and appeal will be rejected straightway.

The fitness certificate on Form-3 is essential to consider the case for Review Medical Examination and not for any other purpose. Form-3 (medical fitness certificate) issued by Medical Officer of any Hospital below District Hospital will not be accepted. It should be issued by the medical officer of concerned speciality from District Hospital and above, along with registration no. given by MCI/ State Medical Council.

Those candidates whose appeal are found in order will be issued call letters to appear for Review Medical Examination and their list will also be uploaded on the SSB website <a href="https://www.ssbrectt.gov.in">www.ssbrectt.gov.in</a>.

The decision of the Review Medical Examination Board will be final and no 2<sup>nd</sup> appeal will be entertained by SSB. No correspondence in this regard will be entertained by SSB at later stage.

- <u>NOTE:</u>- (a) It should, however, be clearly understood that the Selection Board reserves absolute discretion to reject or accept any candidate after considering the report of the medical board.
- (b) Being declared FIT in Medical Examination will in no way give any legal claim or right to any candidate for final selection/appointment to the post of CT(GD) through remusteration as the selection will be strictly as per merit.

### 5. Scanning/Evaluation of Answer sheets:-

- (1) Scanning of OMR answer sheets shall be done with the help of outsourced firm authorized by SSB under the overall supervision of Board of Officers detailed by FHQ, SSB.
  - (2) Re-evaluation of OMR (Answer sheets) will not be permitted.
- (3) Answer sheets and all other records of examination will be preserved by the concerned Chairman who will be nominated to conduct examination for a period of one year from the date of publication of the result by the Director General, SSB, if there is no litigation pending.



- 6. <u>Final selection:</u> a) After completion of Review Medical Examination (RME), the final selection list will be generated on the basis of marks obtained in written test. It is hereby emphasized that the candidate who merely secures the qualifying marks and found medically fit, may not have any right for his/her final selection since the cut off marks will be determined based on the number of vacancies after completion of whole recruitment process.
- b) If, two or more candidates secure the same marks in the written test, the candidate older in age will be assigned the higher merit. If, the tie still persists, the candidate with the longer service in SSB will be placed higher in the merit list.
- 7. A candidate who is or has been declared to be guilty of misconduct or misbehavior in connection with the examination may be liable:-
  - (a) to be disqualified from the examination for which he/she is the candidate; or
  - (b) to be debarred for a specified period of subsequent examination(s) and
  - (c) to face disciplinary action under SSB Act & Rules.
- 8. <u>Last date of submission of application</u>:- The willing and eligible candidates are required to submit their applications on prescribed proforma (copy enclosed) along with necessary documents to their respective units, as per detail given below:-
- (i) Last date for submission of applications by eligible candidates to their units will be 07.06.2019 repeat 07.06.2019.
- (ii) After proper scrutiny of applications, the unit concerned will forward the applications of eligible candidates only to ARC Centre at RTC,SSB Gorakhpur by 27.06.2019 repeat 27.06.2019.
- (iii) After proper scrutiny of applications, <u>ARC, RTC, SSB</u> <u>Gorakhpur</u> will forward the list of eligible candidates in soft and hard copies to <u>Recruitment Branch, FHQ, SSB by 18.07.2019 repeat 18.07.2019</u> for allotment of Roll Number sequences.
- (iv) Applications received after closing date at Units and RTC, SSB, Gorakhpur (UP) i.e. 07.06.2019 & 27.06.2019 respectively will not be entertained.
- (v) Head of the unit will sent the applications in consolidate manner of only those CTs(Tradesmen) and CTs(Orderlies) who fulfill the eligibility conditions as prescribed above, to ARC RTC, SSB, Gorakhpur. Similarly, Second-In-Command (Estt), FHQ, SSB, New Delhi will forward the applications/willingness in respect of the eligible candidates posted at FHQ, SSB, New Delhi to ARC within stipulated time. The personnel posted in new Bns raised at various locations i.e. TCs & ATCs etc. will submit their applications through the units where their Service Records are being maintained.
