2. Candidate applying for more than one post, should apply in separate application for each post.
3. Applicants should mention the name of the post applied for and the community to which the applicant belongs, in the top of the cover for ready reference.
4. Applicants should submit only **one application for each of the posts of his/her choice**. Otherwise, it will be summarily rejected.
5. Recent Passport size colour photograph of the candidate should be affixed on the application in the box provided with self – attestation. The Photograph should not be stapled.
6. Incomplete applications will be summarily rejected. If any of the claim of the applicant is found to be false, the application of such candidates will be rejected without any notice.
7. All further communications will be made only through this court’s official website <https://districts.ecourts.gov.in/tiruppur>. No individual communication will be sent to the applicants other than the communication made in the District Court website.
