**WALK-IN INTERVIEW FOR THE POST OF SENIOR RESIDENT (PSYCHIATRY)**

Deep Chand Bandhu Hospital invites application for a Walk-in-interview for filling up **ONE (01) vacant post of Senior Residents for adolescent and Juvenile Deaddiction ward on Contractual basis**. Only candidates who fulfil the eligibility criteria as per Residency scheme may appear before the **interview panel on 04/07/2019 At 9:30 AM to 12:00 NOON in conference Room , IIIrd Flor, Admn Block** with their original documents alongwith the photo copy of the following documents :-

1. **Qualification** : As per residency scheme: MBBS with Post Graduate Degree in Psychiatry/ or Diploma in Psychological Medicine from a recognised university/ institution.
2. **Tenure**: The tenure will be initially for a period of 89 days which will be extended to a maximum period of 3 years subject to approval of the competent authority.
3. **Age limit**: 37 years for GEN, 5 years relaxable for SC/ST and 3 years for OBC candidates (belonging to Delhi only).
04. **DMC Registration Certificate**.

Further, in case of non availability of candidates, as per the relevant scheme mentioned above, candidates may be considered in terms of the **relaxation of provision** as per circular No. F.121/26/2010/H&FW/1996-2045 dated 10.06.2011 of Deptt. of H&FW, GNCT of Delhi with the following relaxation :-

1. In case of non availability of fresh candidates, candidates who have completed 03 years of Residency as Senior Residents also be allowed to appear in the interview.
2. Separate merit lists for fresh candidates and for other (i.e. those who have competed 3 years of Sr. Residency) would be prepared.
3. Firstly, the list containing the names of fresh candidates would be exhausted for appointment and the second list would be used only after that.
4. Reservation of Person with Disability will be as per Government Rules.

**Note :-**

(1) Self attested photocopies of certificates/testimonials/documents must be submitted and bring originals along with for verification in support of details submitted in the application.

(2) Corrigendum, if any, shall be posted only on Web Site.

(3) No correspondence or personal enquiries shall be entertained.

(4) No TA/DA will be paid for the interview.

(5) All candidates selected will be required to undergo medical examination for fitness in their respective hospitals of posting before joining.

**OTHER CONDITIONS OF RECRUITMENT (Senior Resident):-**

1. The tenure of Senior Resident (Psychiatry) is for a period of 89 days which will be extended on work and conduct to a maximum period of 3 years subject to approval of the competent authority.
2. Other service conditions as prescribed from time to time by the GNCTD will be applicable.
3. The candidate who are already in Govt. service should submit NOC from the HOD of the present place of posting.
4. Their service will be governed by residency scheme.
5. Firstly, the list containing names of fresh candidates would be exhausted for appointment as senior residents and the second list would be used only after that.

**JURISDICTION OF DISPUTE:** - In case of any legal dispute the jurisdiction of court will be Delhi/New Delhi only.
