Out of 100 marks, 80 marks will be for knowledge on above referred subjects and 20 marks will be for personality, health and fitness of the candidates.
- 2. <u>Lower Division Clerk:</u> The Examination shall be made through viva-voce only. The viva voce including test of personality and knowledge in English, Bengali, MS Office, Internet, Emailing, General Knowledge and Office Management etc. The total marks for examination shall be 100. Out of 100 marks, 80 marks will be for knowledge on above referred subjects and 20 marks will be for personality, health and fitness of the candidates.
