1. **Name of the post:** Senior Agricultural Engineer
2. **Number of posts:** One
3. **Classification of post:** General Central Service, Group 'A' Gazetted, Non-Ministerial
4. **Pay Scale:** Level 11 (Rs. 67700-208700) in pay matrix.
5. **Age Limit:** The maximum age limit for appointment by deputation (including short term contract) shall not be exceeding 56 years as on the closing date of receipt of applications.
6. **Eligibility Conditions for appointment on deputation (including short term contract) basis:**

Officers under the Central Government or state government or union territory administrations or public sector undertakings or agricultural universities or recognised research institutes or councils or semi-government or autonomous or statutory organisations :

- (a) (i) holding analogous posts on regular basis in the parent cadre or department; or
- (ii) With five years' service in the grade rendered after appointment thereto on a regular basis in Level-10 (Rs. 56100-177500) in the pay matrix or equivalent in the parent cadre or department; or
- (iii) With seven years' service in the grade rendered after appointment thereto on a regular basis in Level-7 (Rs. 44900-142400) in the pay matrix or equivalent in the parent cadre or department; and

- (b) Possessing the following educational qualifications and experience:-

Essential:

- (i) Degree in Agricultural Engineering or Mechanical Engineering of a recognised University or Institute;
- and
- (ii) Five years' experience in operation and maintenance of tractors, agricultural machinery and allied equipments including teaching experience in any Government or private listed organisations;

- Five years' experience in handling independently testing and evaluation of farm machinery and agricultural implements in any Government or private listed organisation.

Desirable:

Post Graduate Degree in Agricultural Engineering from a recognised University or Institute.

Note 1- The Departmental Officers in the feeder category who are in direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

Note 2- For the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to the 1st January, 2006, i.e., the date from which the revised pay structure based on the Sixth Central Pay Commission recommendations has been extended, shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the Pay Commission except where there has been merger of more than one pre-revised grade pay or scale of pay into one grade with a common grade pay or pay scale and where this benefit will extend only for the post(s) for which that grade pay or pay scale is the normal replacement level without any upgradation.
