GENERAL TERMS AND CONDITIONS OF RECRUITMENT OF ASSISTANT ENGINEER (ELECTRICAL / Civil) ON REGULAR BASIS

1. <u>Minimum Educational & other Qualifications</u>

- (i) Full Time B.E./B.Tech. (Electrical/Civil) from AICTE approved college/university/institute.
- (ii) Qualified and valid (up to last date of submission of application form) GATE Score Card in the relevant engineering stream.
- (iii) If the GATE score/marks obtained for two or more candidates are same then determination of merit shall be as under:
 - a. The older candidate shall be given preference as per date of birth.
 - **b.** In case of same date of birth, preference will be given to candidates securing higher marks in the qualifying exam i.e. Graduation Degree.
 - c. In a situation when both the above conditions are similar for more than one applicant, then preference will be given to candidates securing higher marks in the Class $10^{\rm th}$ examination.

2. <u>Age Limit</u>

2.1 The minimum and maximum age of the candidates shall be calculated as on 1st January of calendar year i.e01/01/2019. Minimum age limit is 21 years and maximum age limit for different category shall be as under:-

- 2.2 Age Relaxation will be applicable only if there is vacancy for reserved Category (SC/ST/OBC(Non-Creamy Layer) and belonging to MP Domicile as wellOtherwise candidate will be treated as UR.Female Candidate(Mp Domicile) will get 5 years of age relaxation in upper age limit.
- 2.3 With All age relaxation max age limit won't be more than 35 years. No Age Relaxation will be providing to Non Domicile Candidate for all categories.

3. How to apply

- 3.1 Applications shall be received through MPOnline Portal (www.mponline.gov.in) only. Link to the website of MP Online will also be provided on the website(s) of the Company(s).
- 3.2 The scanned copy of following documents shall be uploaded by the applicant:
 - (i) High School Examination mark sheet in support of date of birth.
 - (ii) Marksheet of 12th/Diploma.
 - (iii) Mark sheet of full time B.E./B.Tech. (Electrical / Civil) final/last semester/year.
 - (iv) Qualified and valid GATE Score Card in the relevant engineering stream (valid up to last date of submission of application).
 - (v) Caste certificate (Permanent), (in case of reserve category candidates) issued by Sub Divisional Officer (Revenue) of MP.
 - (vi) MP Domicile certificate along with Caste certificate, (as the case may be) in case of candidates seeking age relaxation.
 - (vii) The Candidate of OBC category non creamy layer has to submit income certificate of last three years income of their parents issued by Tahsildar in the current financial year.

4. <u>Application fee and other charges</u>

- 4.1 Application fees for all candidates shall be Rs. 200/-.
- 4.2 The applications can also be submitted through MP Online Kiosks and the payment can be made in cash at the Kiosk.

5. <u>Selection Process</u>

- 5.1 Online application will be invited through MP Online. The application form will be live for a period of 1 month from application start date as mentioned in the advertisement.
- Based on Gate Score, merit list shall be prepared. 1 Common Merit List and four category wise merit list (with proper allotment for Female quota if there is vacancy for reserved category).

6. <u>Selection and appointment</u>

- 6.1 **Merit list preparation –** One common merit list and four category wise merit list (with proper allotment of Female) will be prepared.
- 6.2 **Result Declaration** -Based on merit, provisional list of shortlisted candidates will be notified on the website.
- 6.3 Time period for document verification Provisional shortlisted candidates will be called for verification of documents. Minimum 15 day time will be given for document verification. After verification of documents, successful candidates may be appointed provisionally as Assistant Engineer (Electrical /Civil) based on vacancy/requirement.

7. Reservation

- 7.1 Posts will be reserved for SC/ST/OBC (Non Creamy Layer) Category Candidates of MP Domicile.
- 7.2 The reservation of posts meant for SC/ST/OBC (Non Creamy Layer) shall be applicable only for the candidates having Madhya Pradesh domicile and caste certificate issued by SDO (Revenue) of MP.
- 7.3 33% horizontal reservation will also be given to women candidates as per MP Government prevailing rules.

8. <u>General Conditions Regarding Eligibility</u>

- 8.1 The candidate should be an Indian national
- 8.2 The Candidates working in Government/Semi Government/Public Sector organizations, satisfying the eligibility criterion, education and age, shall have to produce NOC at the time of document verification.

 - (vi) Caste Certificate (issued by SDO, Revenue) of MP in case of applying against SC/ST/OBC (Non-creamy layer)(If Applicable)

- (vii) Medical disability certificate issued by Medical Board.(If Applicable)
- (viii) Income Certificate of last three years income of parents issued by Tehsildar (in case of candidate applying for OBC Non-creamy layer reserved seats).(If Applicable)
