I. COMPANY PROFILE

STCL Limited is wholly owned subsidiary of the State Trading Corporation of India Limited (STC Ltd.) with the administrative jurisdiction of Department of Commerce, Ministry of Commerce and Industry. The company is under winding up and not a going concern. The company is following up the recovery of outstanding from various defaulting business associates.

The company employed 11 regular employees (Executive 5 and Non-executive: 6) as on 31.03.2019.

Its Registered office is at Bengaluru.

The authorized and paid up capital of the Company is Rs.5.00 crore and Rs.1.50 crore respectively as on March 31, 2019.

II. JOB DESCRIPTION AND RESPONSIBILITIES

Managing Director is the Chief Executive of the Corporation and is responsible to the Board of Directors, Holding Company and Government of India. He is responsible for all the activities of the Corporation including personnel, financial and commercial management, corporate planning and project implementation. 3. For candidates from SPSE/ Private Sector

a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.

b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.
