## Expression of interest for Para-legal Volunteers

Expression of interest are invited from willing persons for engagement of 100 nos. of Para-Legal Volunteers in District Legal services Authority, Bargarh for a tenure of one year.

### Eligibility Criteria

The persons fulfilling the following criteria may apply for selection of Para-Legal Volunteers for District Legal services Authority, Bargarh.

1. Teachers (including retired teachers)
2. Retired Government Servants and senior citizens.
3. Anganwadi Workers.
4. Doctor / Physician.
5. MSW Students and Teachers.
6. Students and Law Students (till they enroll as lawyer).
7. Members of Non-political, Services oriented Non-Governmental Organizations and Clubs.
8. Members of Women Neighborhood Groups, Maithri Sanghams and other Self Help Group including of marginalized / vulnerable group.
9. Educated prisoners with good behavior, serving long term sentence in prison.
10. Any other persons whom the District Legal Services Authority deems fit to be identified as Para-Legal Volunteers.

### Minimum Educational Qualification

The PLVs shall be literate preferably matriculate, with a capacity for overall comprehension.

### Selection

The Para-Legal Volunteers in the District Legal Services Authority will be selected by the State Legal Services Authority, Odisha on the recommendation of the Selection committee of DLSAs.

### Remuneration

The work of Para-Legal Volunteers does not carry any salary, remuneration or wages except honorarium fixed by the NALSA from time to time. At present Rs. 500/- per day of their rendering service.

### Removal/ Termination

The Para-Legal Volunteers shall be disqualified and removed from the panel, by the

Chairman District Legal Services Authority, if he/she:

1. Fails to evince interest in the scheme.
2. Has been adjudged insolvent.
3. Has been accused of an offence.
4. Has become physically or mentally incapable.
5. Has so abused his/her position or misconduct in any manner as to render his/her continuance prejudice to the public interest.
6. If he/she is an active political enthusiast of a political party.

The willing persons fulfilling the above criteria may submit their written expression of interest in the prescribed format along with two nos. of pass port size photographs and a self addressed stamped envelope to **the Chairman, District Legal Services Authority, Civil Courts Premises, Bargarh** by **30.08.2019**. The Applications received after due date shall not be considered.

The selection of the Para-Legal Volunteers shall be made as per the "Empanelment Process" of NALSA Scheme. And the Authority reserves the right to accept or reject any application for expression of interest without assigning any reason thereof.
