- Candidate to ensure their eligibility before applying:-** The candidates should ensure that they fulfill all eligibility conditions prescribed for the post Eligibility of the candidates for the post notified in this notification would be decided on the basis of the information furnished by them. If at any stage of recruitment or thereafter, it is found that any information furnished by the candidate in his/her application is false/incorrect or the candidate has suppressed any relevant information or the candidate otherwise does not satisfy the eligibility criteria for the post(s), his/her candidature will be cancelled forthwith.
- Railway Administration will not be responsible for late delivery and postal delay.
