II. Key Responsibilities of Project Consultant - CBS Management:

The primary duties and responsibilities of Project Consultant - CBS Management shall be as follows:

- To study and understand the present status and future plans with respect to CBS implementation.
- ii. Carrying out day to day IT Project Governance which shall include:
 - a. Monitoring of activities of the CBS implementation/ support viz-a-viz project plan on a day to day basis and reporting the progress on a fortnightly basis.
 - b. To monitor the Service Level across all lines of operations.
 - c. Recommend payments to the service provider based on terms of contract, Service Level agreement cross all lines of operations and actual service quality.
- iii. Vendor Management for CBS and IT Services.
- iv. Verify and report the IT System at DC, DR and all the Network system available on monthly basis with regard to security threat.
- v. Any other work assigned from time to time from time to time.

III. Qualification:

Graduation degree with at least 55% marks/ equivalent grade points in Computer Science/IT, Management, and other allied fields and Post-graduation degree with at-least 50% marks/ equivalent grade points in Computer Science/IT and Management, and other allied fields
