I. COMPANY PROFILE

AAI was incorporated by merging International Airports Authority of India and National Airports Authority with the objective to have an integrated development, expansion and modernization of the airports in India of international standards. It is a Schedule 'A'/ Miniratna (Category-1) CPSE in Transportation Services sector with the administrative jurisdiction of Ministry of Civil Aviation. The Corporate office of the Authority is located at New Delhi. The company emloyed 17432 regular employees(Executives 9630 & Non-executives 7802) as on 31.03.2019.

The Authorized and paid up Capital t of AAI is N.A. and Rs.656.56 crores respectively as on 31.01.2019.

The shareholding of the Government of India in the AAI is 100%.

II. JOB DESCRIPTION AND RESPONSIBILITIES

Member (Finance) shall be a member of the Board of AAI and shall report to Chairman. He shall be overall in-charge of finance, accounts and financial operation of the organization. He shall also be responsible for evolving, formulating policies and strategies relating to entire gamut of financial operation, including resource mobilization and statutory compliances. He is excepted to play a leadership role and provide effective support in achieving sustained growth of the organization's business.

2. EMPLOYMENT STATUS:

3. QUALIFICATION:

Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE other than the one to which the candidate belongs.

3. For candidates from SPSE/ Private Sector

- a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.
- b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.
