**RE - ADVERTISEMENT**

Online applications are invited from citizens of India who are holding the post of Associate Professor/Professor for filling up of 1 (one) post of Principal for Govt. Law College of Arunachal Pradesh in the Pay Band-4 Rs. 37400-67000+Academic Grade Pay (AGP) Rs. 10000/- plus Special Allowances of Rs.2000/- (Pre-Revised) per month plus other allowances as admissible to Arunachal Pradesh Govt. employees from time to time. The lone post is un-reserved (open competition).

(I) **AGE** : The maximum age limit of the candidate for the post is 55 years **as on 31.12.2019.**

(II) **EDUCATIONAL QUALIFICATION:-**

- (1) Master's Degree in Law with at least 55% marks (or equivalent grade in a point scale wherever grading system is followed from a recognized University. However, relaxation of 5 % of marks shall be allowed for the candidates of Scheduled Tribes/Scheduled Castes.
- (2) A Ph.D. Degree in Law disciplines in the institution concerned with evidence of published works and research guidance.
- (3) Associate Professor/Professor with a total experience of 15(fifteen) years of teaching/ research/administration in Universities, Colleges and other Institutions of higher education.

"A minimum score as stipulated in the Academic Performances Indicator (API) based on Performance Based Appraisal System (PBAS), as set out in the Regulation in Appendix-III for direct recruitment of Professors in Colleges. (Candidates should obtain a copy of API score from concerned authority and enclose it with application form).

The term of appointment of the College Principal shall be five years with eligibility for reappointment for one more term only after a similar Selection Committee process which shall take into account an external peer review, its recommendation and its outcomes. The framework of the external peer review shall be as specified by the UGC.

(III) **METHOD OF SELECTION:-**

The eligible candidates will have to appear in an Interview/Viva-voce to be conducted by the Commission. The final selection of the candidate will be made on the basis of performance in the Interview/Viva-Voce.

Candidates called for the Interview shall have to appear on their own expenses.

(IV) **FEE**: Candidates are required to pay fee of Rs.100 /- through online.

(V) **HOW TO APPLY:-** Candidates are required to apply online only using Website [www.appsonline.in](http://www.appsonline.in). Brief instruction for filling up online application is available on the above mentioned Website.


