4.1	Applicants are advised to submit the application with all supporting documents to the University well in advance without waiting till last date, to avoid postal delay or any other unforeseen problems. The University will not be held responsible for any postal delay at any stage.
4.2	The prescribed qualification and experience are minimum and the mere fact that a candidate possesses the same will not entitle him/her for being called for interview. The University reserves the right to restrict the candidates to be called for interview to a reasonable number on the basis of qualifications and experience higher than the minimum prescribed as decided by the <u>duly constituted Screening Committee(s) and approved by the Competent Authority based on prescribed norms of the University.</u> The Screening committee shall scrutinize the application as per UGC/NCTE norms. The list of shortlisted and not shortlisted candidates will be displayed in the website. Call letters for attending interview will be sent <u>only to the short-listed candidates by Speed Post or Registered Post or Courier and also by email.</u> The number of candidates to be called for interview will be as per the decision of the University.
