ADVERTISEMENT

The Search Committee constituted under sub-section (3) of Section 4 of the Meghalaya Lokayukta Act, 2014 hereby invites Applications in Prescribed Form (Annexure – A) for filling up 2 (two) posts of Members in the Lokayukta of Meghalaya on the following terms and conditions.

Terms & Conditions:-

1. Members in the Lokayukta of Meghalaya – For filling 2 (two) Posts as follows,-

(i) 1 (one) Post for Judicial Member,-

Requisite Qualification for the Post:

- (a) a person who is or has been a Judge of the High Court, or
- (b) who is eligible to be a Judge of the High Court.

(ii) 1 (one) Post for non-Judicial Member,-

Requisite Qualification for the Post:

- (a) a person of impeccable integrity, outstanding ability having special knowledge and expertise of not less than twenty-five years in the matters relating to anti-corruption policy, public administration, vigilance, finance including insurance and banking, law, and management.

Persons applying for the above mentioned post at para 1 of this Advertisement shall not be eligible as per sub-section (4) of Section 3 of the Meghalaya Lokayukta Act, 2014 (Act No. 4 of 2014) if he or she is,-

- (i) a member of Parliament or a member of the Legislature of any State or Union territory; or
- (ii) a person convicted of any offence involving moral turpitude; or
- (iii) a person of less than forty-five years of age on the date of assuming office as Chairperson or Member, as the case may be;
- (iv) a member of any Panchayat or Municipality or District Council; or
- (v) a person who has been removed or dismissed from service of the Union or a State, and shall not hold any office of trust or profit (other

than his office as the Chairperson or a Member) or be connected with any political party or carry on any business or practice any profession.

2.Age Criteria:

Person applying for the post of Members of the Meghalaya Lokayukta as at para 1 of this Advertisement should not be less than 45 (forty five) years of age as on date of publication of the Advertisement.

3.Tenure of the posts:

The person empanelled as Members of the Meghalaya Lokayukta shall hold office for a term of **5 (five) years** from the date of entering his office or until such person attains the age of seventy years, whichever is earlier.

4.Salaries and Allowances:

The Salaries and Allowances shall be as per the terms and conditions as specified under Section 7 of the Meghalaya Lokayukta Act, 2014 as follows;

(1) The salaries and allowances of persons appointed as Members of the Meghalaya Lokayukta shall be the same as those of a Judge of the High Court.

Procedure for Applying the Posts:-

5. All applicants, whether nominated or those who are applying directly in response to the **Advertisement**, must submit their applications in the **prescribed proforma** which is enclosed as Annexure - A. Applications which are not in the prescribed proforma will be summarily rejected.

Application, complete in all respects along with latest Passport Size photo and duly signed by the applicants, must be addressed to the Additional Secretary to the Govt. of Meghalaya, Political Department and Convenor of the Search Committee of Lokayukta, Room No.403, Meghalaya (C) Secretariat, Additional Building, Shillong-793001 and should reach latest by **4:30 P.M. on 03.01.2020.**
