### SPECIALIST OFFICERS RECRUITMENT PROJECT 2019-20

This has reference to our advertisement dated 06.04.2019 for recruitment of 92 posts of Specialist Officers in Allahabad Bank published in various papers and also on Allahabad Banks' Website under Career Section as "Specialist Officers Recruitment Project 2019-20". The On-line written test was held on 23.06.2019 & interview conducted on 16-19th & 21st October, 2019 at various centres. Based on the performance in the On-line test and interview, merit list has been prepared. Accordingly, the following candidates have been found to be successful.

It may please be noted that the candidates who have applied for the post other than Civil Engineer (JMG Scale-I) have to submit details of requisite work experience as stipulated in the advertisement in the proforma available in the website at the time of Pre-employment formalities failing which they will not be allowed to join in the Bank's service.

Candidates with following Roll. Nos./Names have been selected provisionally for the various posts based on their performance in the On-line test and interview. Final selection is subject to the candidate fulfilling the eligibility criteria and identity verification to the satisfaction of the Bank. This does not constitute an offer of employment.
