### **NOTICE OF PUBLIC APPOINTMENT**

Applications are invited to fill up 15 temporary posts of Peon-cum-Mali-cum-Chowkidar (in the categories of General-06, General (ESM)-01, SC-03, BC'A'-02, BC'A'(ESM)-01 and BC'B'-02) in Bhiwani Sessions Division, subject to continuation of said temporary posts for next financial year, in the pay scale of DL(16900-53500) plus usual allowances as admissible to Haryana Government Employees from time to time.

Note:-Number of vacancies may increase or decrease on creation or withdrawal of Courts or otherwise.

## 1. **Qualification**:

Middle Standard pass and having knowledge of Hindi/Punjabi.

### 2. **Age Limit:**

No person shall be recruited to the service if he/she is less than 18 years or is more than 42 years of age as on 01.01.2019, provided that relaxation in upper age limit is admissible to the reserved categories as per instructions of the Hon'ble High Court of Punjab and Haryana at Chandigarh and/or Haryana Government.

### 3. Last date:

The last date for receipt of the applications by post, by hand or by any other mode is 14.01.2020 upto 05:00 P.M. Applications received thereafter shall be straightaway refused without any further correspondence. Delay on the part of the postal or other authorities shall be no ground for entertaining the applications received after due date.
