

## **EMPLOYMENT NOTICE**

Applications on plain paper furnishing particulars of the post applied for, Name; Father's name; Date of Birth; Present Address; Permanent Address; Qualification; whether previously applied in any Sessions Division of Haryana, if so, its outcome; whether belonging to SC/ST/BC and present employment, if any, contact number, are invited for eight (08) posts of Stenographer Grade-III (General-05, SC-01, BC(A)-01, General (ESM)- 01) on ad-hoc basis on 50% of initial Pay (Pay in Pay Band + Grade Pay + DA) of Fresh Entrant Regular Employee after 01.01.2006 or on the wages fixed by the Deputy Commissioner under the Minimum Wages Act, whichever is higher, for a period of six months or till regular appointments are made by the Hon'ble High Court of Punjab and Haryana, Chandigarh, whichever is earlier, so as to reach the office of undersigned by 31.12.2019 upto 5.00 P.M. The number of posts may increase or decrease. Provided that where no candidate of reserved category is available then appointment shall be made from general category.

### **ESSENTIAL QUALIFICATION**

The applicant should possess a degree of Bachelor of Arts or Bachelor of Science or Bachelor of Commerce or equivalent thereto from a recognized University and must have proficiency in operation of computers (word processing and spread sheets). The applicant should fulfill the condition of qualification on the last date of receipt of applications.

### **AGE LIMIT**

The applicant should not be less than 18 years and more than 42 years of age as on 01.01.2019. Relaxation in age to the reserved categories as per Haryana Government instructions.

**MODE OF SELECTION**

The applicant shall have to pass a test of 80 w.p.m. in English shorthand and 20 w.p.m. in transcription of the same on computer. He/she shall also have to qualify computer proficiency test (word processing and spread sheets). Marks of proficiency test would not be counted towards the final merit as it is qualifying in nature. Select list will be prepared on the basis of merit.

**DATE OF EXAMINATION**


The applicants who fulfill the aforesaid qualification for the post of Stenographer Grade-III on ad-hoc basis will appear for shorthand test/computer proficiency test in Judicial Courts Complex, Sector-12, Karnal on the date to be intimated later-on on the official website of this office i.e. <https://districts.ecourts.gov.in/india/haryana/karnal/recruit> The applicants should bring their original testimonials at the time of shorthand test/computer proficiency test. No separate call letters for the shorthand test/computer proficiency test shall be sent to the applicants.

**LAST DATE**

The last date for receipt of the applications shall be **31.12.2019**. No application received thereafter shall be entertained in any case. Delay on the part of postal authorities or otherwise shall not be a ground for entertaining the applications received after due date. The incomplete applications shall be straightway rejected without any information to the candidate.
