ELIGIBILITY

Degree in Engineering or Diploma from the Polytechnics or Engineering Schools of Odisha or equivalent there to on the date of submission of online application form.

PLAN OF EXAMINATION:

Stage-I-Main Written Examination - 200 marks-Two papers (Objective type)

Paper-I-Composite Paper (General English, Odia Language & General Studies,)-100 marks.

Paper-II-Technical Paper-200 marks(0.5 negative mark per wrong answer).

Candidates three times of vacancies in order of merit category wise basing on the marks secured in Written Examination shall be shortlisted for Viva Voce Test.

Stage-II-Viva Voce Test- 30 marks

Select List-The Select List shall be prepared in order of merit category wise basing on the marks secured in the Main Written Exam. and Viva Voce Test teken together & found eligible in verification of original documents.
