- 13 seats are reserved for PWD (Ortho) Candidates and 07 seats from UR candidates are reserved for EWS Candidates includes anticipated vacancies. The Number of Vacant post indicated as above is provisional, Vacancy may increase or decrease at the time of selection. This is subjected to change without any notice.

**2. Emoluments:** -

Pay scale Rs. 56100-1,77,500/- plus applicable admissible allowances in pay matrix (level 10) under CCS (Revised Pay) Rules, 2016 at entry level.

**3. Eligibility:-**

- MBBS from a recognized University.
- Candidates who have completed their MBBS from Delhi must have Delhi Medical Council Provisional Certificate and DMC Permanent Registration Certificate/Acknowledgement receipt for Permanent DMC registration with the undertaking to submit Permanent DMC certificate at the time of joining.
- Candidates who have completed their MBBS outside Delhi must have permanent state Medical Council Certificate and DMC Permanent Registration Certificate/Acknowledgement receipt for Permanent DMC registration with the undertaking to submit Permanent DMC certificate at the time of joining.
- Candidates who have completed their MBBS outside India must have Permanent Delhi Medical Council Registration Certificate. Application only with acknowledgement of DMC will not be considered.
- Only those candidates who have completed / likely to complete Internship by **31.12.2019** may apply.
- The candidates who completed Internship before **31.12.2017** need not apply; as such candidates would not be eligible.
- Those have already done/doing six months/more than six months Jr. Residency in Government organization are not eligible.

**4. Age Limit:**

- Not exceeding 30 years for UR (relax able by 5 years for SC/ST, 3 years for OBC) as on **31.12.2019**.
- Age Relaxation of 10 years for Persons with Disability 15 years for SC/ST and 13 years for OBC candidates

**5. Reservation:**

All reservations will be considered in the above posts strictly in accordance with prescribed norms/rules.

- SC/ST candidates to submit copy of community/caste certificate from desirable authority.
- OBC candidates should submit OBC Certificate as per given **Annexure-II having date of issue on or after 31.12.2016 vide OM No. 36036/2/2013-Estt. (Res-I) dated 31.03.2016 of DOPT, Ministry of Personal & Public Grievance & Pensions, New Delhi.**
- Persons with disability (PWD) to produce/submit a certificate issued by a competent medical authority.



d) EWS candidates to submit copy of Income & Asset Certificate as per given annexure –III **having date of issue on or after 31.01.2019 vide OM No. 36039/1/2019-Estt(Res) dated 31.01.2019 of DOPT, Ministry of Personal & Public Grievance & Pensions, New Delhi**

**6. Terms & Condition of Recruitment:**

- a) **Prescribed Application form duly filled & signed (Annexure-I)** should be accompanied with self attested copies of Final mark sheet of M.B.B.S examination, DMC registration certificate, Internship completion certificate, Category certificate, 10<sup>th</sup> class passing certificate and copy of Aadhar Card along with **non-refundable Demand Draft of Rs. 800/-for UR & OBC candidates in favor of PAO, Dr. Ram Manohar Lohia Hospital, New Delhi-110001**, Demand draft should be issued after the date of advertisement **EWS/SC/ST & PWD Candidates are exempted from Fee.** Application form addressed to **The Medical Superintendent, Dr. R.M.L Hospital, New Delhi** should reach **Central Diary and Dispatch Section, Near Gate no. 1, Dr. Ram Manohar Lohia Hospital, New Delhi latest by 31.12.2019 till 4:00 p.m. The hospital will not be responsible for any postal delay.** Application fee once deposited shall not be refunded under any circumstances.
