- (ii) Any relaxation in minimum educational qualification as mentioned above is not permissible.
- (iii) Persons if appointed as Clerk-cum-Typists have to acquire Typing proficiency of **30 W.P.M.** in English or **25 W.P.M.** in Hindi within a period of 4 years from the date of appointment. Till such time their appointment to the category will be provisional.
- (iv) The place of posting will be decided by the South East Central Railway administration at the time of offering appointment to the selected candidates.

3.2. The minimum sports norms for recruitment of sportspersons against sports quota through Open Advertisement for both the team and the individual events in different Pay matrix level or Grade pay/Pay Bands shall be as under:

Additional acceptable sports achievements/Minimum Sports norms for certain disciplines:

3.3 In Athletics:

For posts of Pay Level 2 only: Medal winning performance in National Inter State Senior Athletics Championships may also be considered.

For posts of Pay Level 4 or 5 : Gold medal winner in Open National Championship (Senior), Inter-State Athletics Championships (Senior) and Asian Championship (Senior) may be considered.

3.4 In Badminton:

Sportspersons shall also be considered for recruitment on the basis of their current **Annual All India Ranking** in different levels as per following criteria:

3.5 In Cricket:

In Cricket (Men) at International level, representation of Main Indian Seniors Team in a Test Match or in a Limited Over One Day International Match or in a T-20 Over International Match shall also be considered for recruitment against the posts having Pay Matrix Level 2 or 3.

At National level, following sports achievements in 4 Days/One Day Limited Over/Twenty-20 Over Men's Cricket Championships (**except Vizzy Trophy**) organized under the aegis of BCCI shall also be considered for recruitment against the posts having Pay Matrix; Level 2.

OR

a) Quarter finalist in Senior U-23/U-19 All India Inter State Elite Group Championship and All India Inter State Championship. **OR** b) Participants of Senior U-23/U-19 all India Senior Inter-Zonal Championship

3.6 In Hockey:

In Hockey (men) for recruitment against the posts having Pay Matrix; Level 2 Or 3, Participation in the International Tournaments (Senior or Junior) of four or more nations may also be considered. In Hockey (men) semifinalist in Senior National Championship may also be considered for recruitment in Pay Matrix; Level 2 Or 3.

Note:

- (i) All the championships mentioned above should be conducted under the aegis of recognized International/National/ Sports Federations and also recognized by the Railway Sports Promotion Board(RSPB).
- (ii) The recruitment is for the minimum of the scale of pay.
- (iii) For recruitment of sportspersons, on the basis of sports achievements in Junior National championships, the age groups as mentioned below shall only be considered.

Note: (i) The Sports achievements of current and previous two financial years will be taken in to account for eligibility. Therefore the Sports achievement of 2017-2018 or later date will only be considered.

(ii) Submission of certificates by the candidates from respective National Sports Federations, Indian Olympic Association, indicating that the candidate has actually participated in the field is **mandatory**.

(iii) Sportspersons who have not actually played in field will not be considered.

4. Mode of Selection:

(i) Selection is based on total marks obtained by the candidates. The distribution of marks is as under:

(ii) Trials of the candidates shall be conducted to assess their sports performance and suitability for Railway/Unit team as well as Indian Railways' team. **Trial Committee** shall give its recommendation in terms of either FIT or NOT FIT, for consideration for next stage.

(iii) Selection Procedure:

Selection will be based on performance in sports trials and documents verification to be conducted and finalized by a nominated selection committee. **The venue and date for trials, documents verification etc. will be intimated through website only to the eligible candidates.** Candidates are advised to visit given website regularly. The trials for different Pay Levels may be held separately. Railway administration, South East Central Railway, Bilaspur reserves the right to cancel or modify recruitment process at any time without assigning reasons thereof.

5. Examination Fees:

- (i) **Rs.500** (Rupees five hundred) only for all (except the categories exempted for fee relaxation) with the provision for refunding Rs 400 after deducting bank charges to those eligible candidates who appears in the trial.
- (ii) **Rs. 250** (Rupees two hundreds fifty) for candidates belonging to SC/ST communities, Women, minorities and Economically backward classes with the provision for refunding full amount after deducting bank charges to those eligible candidates who appears in the trial.

6. General Conditions (other than specified above):

- (i) If none of the applicants for Level-4 & Level -5 are found suitable, the applicants of Level-2 & Level-3 may be considered against these posts. However, they will be recruited in Level- 2 and Level-3.
- (ii) Candidate may apply for more than one events also for which separate application to be submitted with paying examination fee separately.
- (iii) Selected candidate has to pass prescribed medical examination for allotted post. The medical exam will be conducted by Railway medical authorities prior to her/his appointment.
- (iv) Candidates belonging to SC/ST communities will be given free traveling authority in second class when called for trials.
- (v) No Accommodation and TA/DA will be provided while appearing in the selections/ trials. Candidates should come prepared to stay at the place of trials for 2-3 days. They have to bring their own sports kit/equipment and should make their own arrangement for stay.
- (vi) Immediately after closing date for online application, the candidate may be called for trial at very short notice for which candidate should be ready.
- (vii) No post is exclusively reserved for any particular Community.
- (viii) Minorities means Muslims, Sikhs, Christians, Buddhists or Zoroastrians(Parsis).
- (ix) Recognized sports achievement should be in the current and/or immediate previous two financial years and sportspersons should be an active player. **Supporting documents should be produced at the time of Trial and documents verification.**
- (x) Non-fulfillment of any of the criteria mentioned in this notification will make the application liable for rejection for which candidate him/her self will be responsible.
- (xi) Selected candidates are liable to be posted anywhere on South East Central Railway.

- (xii) The selection shall be decided purely on the basis of merit. In case more than one sportspersons score the same marks, preference will be given to younger candidate to decide the merit.
- (xiii) The sportspersons, who can be fitted in the South East Central Railway Sports Association team, will only be considered.
- (xiv) Railway administration reserves the right to alter the stages of recruitment or cancel part or whole of any recruitment process at any stage without assigning any reason.
- (xv) Sportspersons recruited against sports quota shall be terminated from service if the information and documents furnished by him/her for recruitment are found incorrect/fake at any stage.
- (xvi) Sportspersons recruited against sports quota shall execute a "Service Bond" for a period of 5 years.
- (xvii) Sportspersons recruited against sports quota will undergo probation period of 2 years. The performance of the sports person shall be reviewed before completion of the probation period.
- (xviii) Sports persons having sports norms for higher Pay Matrix level (Grade Pay) and who have applied against the vacancies for the lower Pay Matrix can be considered for recruitment against the Pay Matrix level applied for only. In such cases the sports persons has to give an undertaking that he/she will not claim for higher pay level after joining the Railways, on the basis of sports achievements he/she has acquired prior to joining Railways.
- (xix) The decision of Railway Administration in connection with selection will be final. For non-selection of the candidates no correspondence will be entertained. Canvassing in any form will disqualify the candidate.
- (xx) Legal Jurisdiction: For any legal dispute, the jurisdiction will be Hon'ble Central Administrative Tribunal, Jabalpur.
- (xxi) For any further clarification candidates are advised to go through the website of SECR i.e. www.secr.indianrailways.gov.in. it is also advised that candidate should visit this website regularly for updated information.

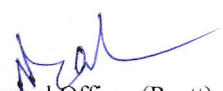

- ii) Application without proper certificate in respect of date of birth, educational qualification, Sports achievements, caste (OBC/SC/ST/OBC declaration) certificate obtained from appropriate authority in prescribed format.
- iii) Candidates should possess the requisite education and sports achievements on the date of notification itself.
- iv) More than one application by the same candidate for the same event.
- v) Applications sent manually; (not submitted online).
- vi) Any other deemed irregularity.
