Invites applications for the following Tenure / Adhoc based posts at **HAL Schools, Bangalore** for the Academic Year 2020-21.

**1. PRT-English : One Post**

Qualification: Graduate in/with English as one of the main subject and B.Ed. with English as one of the teaching methods.

**2. PRT-Social Studies: One Post**

Qualification: Graduate with two subjects out of History, Political Science, Economics, Sociology, Geography OR Hons. Graduate with History or Political Science or Geography as a main subject and B.Ed with any one subject as mentioned in Graduation.

**3. PRT-Kannada : Two Posts**

Qualification: Graduate in/with Kannada as one of the main subject in all 3 years and B.Ed with Kannada as one of the teaching methods.

**4. TGT-Maths : One Post**

Qualification: Graduate in/with Maths as one of the main subject in all 3 years and B.Ed with Maths as one of the teaching methods.

**5. TGT-Science : One Post**

Qualification: Graduation in/with Physics, Chemistry, Biology (PCB) or Physics, Chemistry, Maths (PCM) and B.Ed with Science as one of the teaching subjects.

**6. PGT-Chemistry : One Post**

Qualification: Post Graduate in Chemistry and B.Ed. with Chemistry as one of the teaching methods.

**7. Attender (Male): One Post**

Qualification: SSLC pass

**Pay for Tenure Based posts:**

- Rs.25,500/- plus Admissible DA from time to time for posts at Sl.No. 1 to 3
- Rs.29,200/- plus Admissible DA from time to time for the posts at Sl. No.4 & 5


- Maximum of 45 yrs as on 01.06.2020 for posts at Sl.No. 1 to 5
- Maximum of 50 yrs as on 01.06.2020 for post at Sl.No. 6
- Maximum of 40 yrs as on 01.06.2020 for post at Sl.No.7

**Please Note:**

1. Engagement of personnel on Tenure basis is for a period of 2 years and it is one academic year for Adhoc basis post.
2. Teaching experience of 5 years in Senior Secondary Level (class XI- XII) in CBSE/ICSE Schools is required for PGT post whereas 2 years of experience is required in Middle/High School level (VI to X) for TGT level posts and experience is not mandatory for PRT level posts. However, preference would be given to candidates with experience in CBSE/ICSE Schools even for PRT level posts.
3. For post indicated at Sl.No.7, minimum experience of 3 years in Special School(s) is required. He is required to take care of special needs and attention of Special Children with multiple disabilities while escorting. Candidates should be able to maintain school garden and upkeep / safety of the school premises.
4. Candidates must have secured an aggregate of 50 % in Graduation and 50% in teaching subjects in B.Ed course for posts at Sl. No. 1 to 6.
5. Candidate applying for English & Social Studies posts should have studied in English Medium at the school level and for posts of Science and Maths, medium of instruction with English is required atleast at the Graduation level.
6. Integrated course offered by Regional College of Education would be equated with Graduation and recognized Degree/Diploma in Education. However, candidate should be a Graduate in/with the subject in all the years for the post applied for.
7. Experience of one academic year refers to 10 months, excluding summer vacation.
8. Candidate must attach Experience certificate wherever applicable. In case of a candidate who is working at the time of submitting application, an Appointment letter and latest Salary certificate/Salary slip from the current employer will also be accepted in lieu of Experience Certificate.
9. Only post qualification experience will be considered.
10. The selection will be done through Written Test, Demo and Interview for teaching posts and selection of Attender would be done through Written Test/interview. The date, time and venue of the Demo and Interview will be intimated to the short-listed/eligible candidates by E-mail/Telephonically.
11. Application with incomplete information or applications received after the due date will be summarily rejected.
12. Candidates meeting above eligibility criteria may send their application strictly in the prescribed format which is available at HAL Website ([www.hal-india.com](http://www.hal-india.com)) and HAL Education Committee Website ([www.halec.co.in](http://www.halec.co.in)) along with non refundable Demand draft of Rs.200/- drawn on any Nationalized Bank in favour of '**Secretary –'HAL Education Committee'**.
