- Candidates will be called for interview on the basis of merit of marks obtained in Written Test in the ratio 1:5. Final Selection will be made on the basis of Written Test and Personal Interview.
- Minimum marks for qualifying in the Interview will be 50% for empanelment.
- Weightage of Marks for selection will be 70% in Stage-I(Written Test) & 30% in Stage-II(Interview).

#### Relaxation in the upper age limit for Category I & II Stipendiary Trainees shall be as under:-

- a) Relaxation upto 5 years for SC/ST candidates for the post reserved for SCs/STs.
- b) Relaxation upto 3 years for OBC candidates for the post reserved for OBCs.

Selected candidates will be given training in various aspects of relevant trades, as per prescribed syllabi of each trade and for meeting stringent requirements of HWB. During the period of Training and thereafter, the candidates will be required to attend Round-the-clock shift duties. The place of initial Training will be at HWP (Manuguru/Kota/Talcher/Tuticorin). Hostel accommodation will be provided to the Trainees by Heavy Water Plants. The candidates will not have any choice/option for any particular training programme/training place.

#### **BOND FOR SELECTED CANDIDATES FOR CATEGORY-I & II STIPENDIARY TRAINEES :**

The selected candidates will have to execute a bond to complete the Training period and to serve the Heavy Water Board/Heavy Water Plants or any other Constituent Units of DAE, if offered appointment after the training, for a period of 3 (Three) years after absorption. A trainee who fails to complete the training or serve the Government for 3 years, if offered appointment, will be liable to pay to the Government a sum equivalent to aggregate amount of stipend received by him/her during the period of training alongwith interest thereon.
