1. No TA/DA shall be admissible for attending the proficiency test/interview.
2. Screening test/Proficiency test will be conducted for screening of the provisional eligible candidates and only shortlisted candidates will be given computer test and further called for the interview. Written test/Screening test/proficiency test is a test to check IQ, General knowledge and information of the candidate about concerned subject, those candidates who are unable to get 40% in screening / proficiency test will not be shortlisted for further interview Process.
3. Selection Criteria will be based as per NHM norms.
4. Reservation criteria will be as per Haryana Government policy. Candidates claiming reservation should submit the copy of caste certificate issued by the competent authority.
5. Number of post can be increased or decreased.
