**IMPORTANT:**

- i) Date of activation of the Online Application for the post will be notified in the Detail Advertisement. Candidates are advised to be in constant touch with the above website to apply for the post.
- ii) No Hard copy of the online application is required to be sent to the Commission. The documents as required are to be uploaded while filling up of the online application form and self attested copies of all requisite documents/certificates are to be submitted at the time duly notified by the Commission.
- iii) Before applying for the post the candidate must go through the Detail Advertisement to be published in the above website shortly and ensure their eligibility for the post and to apply through online mode only. If at any stage of recruitment or thereafter, it is found that any information furnished by the candidate in his/her online application is false/incorrect or the candidate has suppressed any relevant information or the candidate otherwise does not satisfy the eligibility criteria prescribed for the post, his/her candidature for the Post/Examination will be cancelled forthwith and he/she may be debarred either temporarily or permanently from appearing any further recruitment examination (s) conducted by the Commission. There is no "Edit" option in the online application form. Candidates should be extra vigilant while filling the online application.
- iv) Candidates have to download admission letter from the above website for appearing the examination at different stages of recruitment. No Admission letter will be sent by post.
- v) PwD candidates have to follow the Advisory Notice published vide No.3453/OSSC dtd.24.10.2019 available in the Commission's website.
- vi) In-service contractual candidates claiming benefits will also have to follow the advisory notice published vide No.3658/ dtd.01.11.2019 available in the Commission's website.

**SCALE OF PAY & CONDITIONS OF SERVICE:** Appointment is contractual initially to be guided by the Odisha Group-C posts (Contractual Appointment) Rules, 2013 and subsequent amendment". Details of the scale of pay shall be published in the detailed advertisement.

**ELIGIBILITY**

- (i) **Age** Must not be below 18 years and above 32 years of age as on 01.01.2019. The upper age is relaxable by 5 years in case of ST, SC, SEBC and Women, 10 years in case of PwD persons and the qualifying years of service in Defence Forces in case of Ex-SM. The in-service contractual employees shall get age relaxation as per provisions contained in the concerned Rules. The PwD candidates in the SC & ST category shall be entitled to get age relaxation of 10 years over & above the normal age relaxation specified for the category. **Special Age relaxation for NTC holder/Apprentice Training holder etc. shall be notified in the detailed advertisement.**
- (ii) **Minimum Educational Qualification:** Candidate must have possess requisite qualification as indicated against each post in the table below and must possess requisite certificate of passing HSC or ME standard in Odia as language subject to apply for the post.


Out of the above vacancies no post is reserved for Sports & Ex-servicemen categories. However, they may claim age relaxation as per rules and have to compete against their own category.
