

## Engagement of Bank's Medical Consultant (BMC) on contract basis with fixed hourly remuneration

The applications should reach the General Manager & O-i-C, Reserve Bank of India, Lilashing Khongnangkhong, Opposite Manipur Legislative Assembly, Imphal-795001 on or before 5.00 p.m. January 14, 2020.

- i) Applicants should possess MBBS degree of any university recognized by the Medical Council of India in the allopathic system of medicine.
- ii) Applicants having post graduate degree in General Medicine can also apply.
- iii) The Applicants should have a minimum of 2 (two) years' experience in any hospital or as Medical Practitioner.
- iv) The applicants should have his/ her own dispensary or place of residence within a radius of 10-15 kms from the Bank's dispensary at Imphal.
- v) The remuneration of the Medical Consultant on contract basis will be fixed with reference to the actual duty hours performed and will be all inclusive.
- vi) The Contract for engagement will be for a period of three years.

### Selection Procedure:

- x) The Reserve Bank of India, Imphal will be conducting an interview for selection of one **Bank Medical Consultant** (BMC) (Category: Unreserved) on contract basis, with fixed hourly remuneration. The interview will take place on January 28, 2020.
- xi) Selection will be made through interview of eligible candidates. The Bank reserves the right to raise the minimum eligibility standards etc. in order to limit the number of candidates to be called for interview. The decision of the Bank in this regard will be final. The Bank will not entertain any correspondence with the applicants who have not been called for the interview.
- xii) The shortlisted applicant after interview will be subjected to medical tests as per prescribed norms before engagement as Bank Medical Consultant (BMC). The cost of these medical tests will have to be borne by the applicant.
- xiii) Candidate selected for the post will be appointed subject to him / her being found medically fit and acceptance of Terms and Conditions and Code of Conduct fixed by the Bank.
- xiv) The selected applicant has to enter into an agreement for Contract with the Bank before engagement as Bank Medical Consultant (on contract basis) with fixed hourly remuneration.
