B. The candidate must possess degree in Education (B.Ed.) except for posts mentioned at serial no. 6, 7, 8 and 9.

2. **Experience:**

The Candidate must possess atleast 05 years of teaching experience in a recognized school/educational organization preferably located in National Capital Territory.

The candidates who possess M. Ed. Degree will be exempted from the requirement of experience.

3. **Age:**

Not more than 45 years as on last date of submission of application.

4. **Tenure:**

Initially the Subject Specific Resource Persons will be engagement upto 31.03.2020. However, the engagement is extendable beyond 31.03.2020 subject to performance review.

5. **Emoluments:**


The Subject Specific Resource Person shall be paid consolidated remuneration of Rs.50798/- per month.

6. **Nature of Duties:**


- a. To plan and provide need based academic resource support;
- b. To provide training to teachers teaching in schools upto Secondary stage;
- c. To plan and organize workshops for academic development of teachers;
- d. To take supervision and monitoring work as assigned;
- e. To design and prepare Teaching Learning Material.

7. **General Conditions:**

- a. **The candidate not having five years of experience or not having Degree in Education (B.Ed.) will not be considered;**
- b. The candidate will be engaged purely on contract basis and will have no claim for regularisation of appointment/regular appointment in the SCERT;
- c. The candidate so engaged on contract basis shall not file any court case regarding salary and/or regularization;



- d. SCERT reserves the right to withdraw/cancel the advertisement and/or the selection process there under. The number of vacancies may also be changed during any stage of the engagement process;
- e. The applicant shall fill up his/her details as recorded in the certificate of Secondary/ Sr. Secondary Board Examinations. Applicants with incomplete/wrong particulars in the prescribed format will entail rejection of their candidature without notice. Only online applications will be considered.
- f. Applications received through mode other than online shall not be entertained under any circumstances.
- g. Experience certificate has to be duly countersigned by the concerned Zonal Deputy Director/Education Officer;
- h. The candidate may be assigned any duty or responsibility related to teacher training/teaching in any DIET under the jurisdiction of SCERT;
- i. The candidate should have working knowledge of Computer such as MS-Office (Word & Excel PPT), Internet and e-mail. An undertaking shall, therefore, be obtained from the candidate that he/she has adequate working knowledge of MS Office and if at any later stage, the undertaking is found to be false, the engagement may be cancelled without any notice
- j. The eligible candidates will be shortlisted on the basis of weightage of educational qualification and experience and will be called for scrutiny of documents and personal interaction which may include classroom teaching to check communication skills and teaching methodology;
- k. **The personal interaction for different disciplines may be held on same day at different venues;**
- l. The candidate who fails to appear on the scheduled dates for scrutiny of documents and personal interaction shall not be considered for the same subsequently;
- m. A panel of candidates will be drawn strictly on the basis of marks and the toppers will be selected. In case of a tie i.e. more than one candidates securing same marks, the younger in age will be selected.
- n. The selected candidates will have to sign a contract agreement with SCERT and in case of breach of any of the condition of contract, the engagement will be cancelled and the agreement will be terminated without giving any notice;
- o. Selected candidates will have to join their duties immediately after getting the engagement letter and in case of non-reporting for duty during the stipulated period, next candidate available in the merit list will be given the offer. No formal intimation or letter for cancellation of the offer will be sent to the candidates in this regard;



- p. The contractual Subject Specific Resource Persons will work during duty hours prescribed for SCERT/DIET, as the case may be. They may be required to work on Saturdays and Sundays in case of need;
- q. The services of any Subject Specific Resource Persons may be terminated without any notice for any lapse/irregularity committed by him/her or the work and conduct not found satisfactory or absence without prior permission of Director, SCERT/Principal, DIET, as the case may be.
- r. The Resource Person shall be eligible for 8 days' leave in a calendar year on pro-rata basis. Therefore, Resource Person shall not draw any remuneration in case of his/her absence beyond 8 days in a year (calculated on pro-rata basis). Also un-availed leave in a calendar year cannot be carried forward to next calendar year.
