Undertakings / Corporations/Companies (excluding bank audit) for carrying out full-fledged Internal Audit works relating to i) Fund management, ii) Budgeting and forecasting, iii) Asset management (including maintenance of assets), iv) Review of billing of SLDC & Transmission wheeling charges, v) Accounting & Reporting, vi) Capital liabilities, vii) Statutory and regulatory compliance, viii) Inventory Management, ix) Expense Management, x) Payroll management, xi) Human resource management, xii) Supplier /Contractor payments etc.

 - b) TA & DA will be reimbursed as per APTRANSCO rules for official journeys performed from the zonal headquarters office allotted to each team., <u>CA on par with Grade-III officers</u> and in respect of <u>2 assistants on par with Grade-III staff</u> of APTRANSCO.
- vi. Tenure : Contract through agreement initially for a period of one year. Further extension will be at the discretion of APTRANSCO with mutually agreed terms and conditions.
