In compliance to Judgment dated 29.01.2020 of Hon'ble Punjab and Haryana High Court, Chandigarh in CWP-PIL bearing No. 6 of 2020, applications in prescribed form are invited from the eligible Indian Citizens for recruitment to the following temporary posts of Specialist Doctors/Doctors for BBMB Hospitals situated at Talwara (Pb), Nangal (Pb) & Sundernagar (HP) on **Contract Basis** under "Policy for Contractual Employment of Doctors and Retired Doctors in BBMB" in **first instance** for one year on full time basis extendable as per requirement by one year successively upto a **maximum period of 5 years on lump-sum payment/fixed emoluments**, the format of prescribed application form which is hoisted on the web site of BBMB www.bbmb.gov.in. The candidates are advised to strictly use this format of the application form only otherwise their application will be rejected. The number of posts may vary to any extent depending upon exigency, either way (increase or decrease) including complete withdrawal. The candidate should invariably mention on top of the Application form the word – **Advt. No., Name and category of the post applied for:-**

1. APPLICATION FEES:

Each application should be accompanied with non-refundable application fees of Rs. 800/- (for Un-reserved/OBC Category), Rs. 400/- for (Scheduled Caste & Scheduled Tribes) by IPO/ Demand Draft (issued after the date of advertisement) drawn in favour of **Sr. Accounts Officer, BBMB, Chandigarh payable at Chandigarh**. No fee shall be charged from Ex-Servicemen, if they are not released from the service at their own request, but their dependents are required to pay the fee, as applicable. No fee shall be charged from Women Candidates of any community. No "fee exemption" is available to OBC male candidates and they are required to pay the full prescribed fee. For PWD* If applying in own category i.e. against reservation of PWD post then no fees is payable otherwise in General Category full fees shall have to be paid by them.

2. IMPORTANT NOTES:

- i. The degree of undergraduate/postgraduate not recognized by the MCI will render the candidate ineligible.
- ii. The qualification and experience will be counted on the last date of submission of applications.
- iii. Details of the Research Work Publications (in annotated form) indicating index/non-index along with attested copies and best seven research works along with citations supported by relevant document, must also be furnished. Any other relevant outstanding National, International achievements in the profession supported by the documents, if any, must also be supplied.
- iv. Departmental Employees are also eligible to apply if they possess the requisite qualification as mentioned above. Serving Government employees should also send their application form through proper channel before closing date.
- v. Offline Application form complete in all respects along with enclosures must be sent on or before 12.02.2020 upto 1600 hours. Applications received late will not be considered. This office would not be responsible for any delay and the applicants are advised to apply well in advance.
- vi. The applicant should clearly specify the post applied and his/her mailing address & Mobile No. on the Application Form while sending his/her application form as per para (v) above.

3. INSTRUCTIONS FOR DEPARTMENTAL EMPLOYEES

- i. Departmental Employees are also eligible to apply if they possess the requisite qualification as mentioned above on the closing date of application. Serving Government employees must send photocopy of their application form through proper channel on or before closing date.

- ii. Copy of offline Application form complete in all respects along with enclosures must reach in the office of undersigned on or before 12.02.2020 upto 1600 hours. This office will not be responsible for any postal delay. Applications received late will not be considered.
- iii. The applicant should send copy of his/her application form through Registered/Speed Post/Courier in the office of Member Secretary/Centralized Staff Selection Committee, BBMB, Plot No.6B, Madhya Marg, Sector-19B, Chandigarh-160019 and clearly specify the post applied on the top of the envelope and his/her mailing address on the envelope.
- iv. Eligible candidates already in service (Govt./Semi Govt./ Corporation or Autonomous Body) are also simultaneously required to apply through proper channel and their applications must reach in due course of time before closing date of receipt of application.
- v. The candidate who is in service will have to produce **No Objection Certificate** at the time of written Test/Interview from his/her Head of Institution/employer otherwise he/she will not be allowed to appear in written test/Interview.

4. GENERAL TERMS AND CONDITIONS:-

- i. **Submission of incomplete application form i.e. without copies of testimonials of prescribed minimum educational qualification as per advertisement, experience certificate (if required), Date of Birth certificate, reservation status with domicile etc. may render the candidate ineligible.**
- ii. The candidates who wish to apply for more than one post, should submit separate application form for each post.
- iii. The number of posts is liable to increase or decrease either way, including complete withdrawal.
- iv. The applications received after the closing date will not be considered.
- v. The benefit of reservation, including the benefit of relaxation in upper age limit in respect of Candidates belonging to reserved category, will be as per Central Govt. instructions issued from time to time.

5. SPECIAL INSTRUCTIONS

- i. The prescribed essential qualifications are minimum and mere possession of the same does not entitle a candidate to be called for written test/Interview. The applicant must possess the minimum Prescribed Qualification on the Closing Date for receipt of applications. If the number of applications received in response to this advertisement is large and it is not convenient or possible for the Centralized Staff Selection Committee to call all the candidates for written/Interview, the Centralized Staff Selection Committee may restrict the number of candidates for written/Interview to a reasonable limit on the basis of qualifications and experience higher than the minimum prescribed in the advertisement or by holding a screening test or by any other method devised by the Centralized Staff Selection Committee, whose decision in the matter shall be final.
- ii. The decision of the Centralized Staff Selection Committee in all matters relating to eligibility, acceptance or rejection of application, mode of selection, etc. will be final and binding on the candidates and no enquiry or correspondence/ communication oral or written shall be entertained in this behalf.
- iii. The selected candidates are liable to be posted in BBMB Hospital, Talwara.
- iv. Canvassing in any form will disqualify the candidate.

6. GENERAL INSTRUCTIONS

- i. A candidate whether belongs to General category or reserved categories can submit only one application for a particular post. Photocopies of essential certificates, like, date of birth, qualification, experience, reservation proof with domicile, if claimed, etc. may be submitted with the application form on or before **12.02.2020 upto 1600 hours**. Applications received late will not be considered. This office would not be responsible for any delay and the applicants are advised to apply well in advance. All the columns of the Application Form should be filled in properly.
- ii. The applicant shall fill in all the columns of the form and write N/A in case any column is not applicable.
- iii. **Relaxation in Age**
The applicant must fulfill the age requirement as on **01.01.2020**. The upper age is relaxable (a) by 5 years for SC/ST candidates & up to 3 years for OBC candidates, (b) to the extent of 5 years for physically handicapped persons on production of Medical certificate from the Competent Authority (c) in case of Ex-servicemen, as per Central Government Recruitment Rules DoPT No.15012/2/2010-Estt.(D) Dated 27.03.2012 as amended from time to time and (d) up to 5 years for persons already in the employment of Central/State Government or their Undertakings/ Autonomous Bodies/Boards/ Corporations.

iv. **Reservation of posts**

- a) In the case of reserved category candidates, the benefit of age relaxation and fee concession (wherever applicable) will be available only to the candidates possessing the reservation certificate issued by the Competent Authority including those as notified by the Central/State Government from time to time.
- b) Candidates seeking benefit of the age relaxation / fee concession under Ex-servicemen quota will include Ex-servicemen himself, his sons and unmarried daughters or daughter-in-law in case no other member of the family has availed the benefit as notified in Central Government Recruitment Rules as amended from time to time. Dependent of such Ex-servicemen will have to produce a certificate of Dependency from the District Sainik Welfare Board, in the prescribed proforma.
- c) Wherever applicable, Persons applying under orthopedically handicapped category having minimum 40% or more Physical defect and deformity as certified/issued by competent authority (Civil Surgeon/PGIMER/Govt. Hospital/Main General Hospital) shall only be eligible for the benefit of age relaxation as permissible under the rules of Central Government.
- d) DoPT/Central Government Reservation Policy is applicable on the present advertisement in BBMB.

NOTES

- i) No TA/DA or any other expenses will be paid for appearing in the written test/Interview.
- ii) An application form will summarily be rejected in the following events and no correspondence in this regard shall be entertained:-
 - a) If a candidate makes more than one application for a particular post or submits same application form for more than one post/category.
