#### Procedure for engagement

- b) The concerned retired officer must clearly mention the name of the location where he / she wants to carry out the audit work.
- c) The concerned retired officer <u>shall also be willing to undertake Inspection & Audit work in other location apart from the preferred location as per the requirement of the Company.</u>

### **Period of Contract**

The initial period of contract will be for a fixed period of 1 year only from the date of joining. The same can be extended for further 2 years at the sole discretion of the Company, on specific request for renewal after expiry of contract period.

#### **Termination of contract:**

Either party may terminate the contract by giving <u>one month's notice</u> in writing or by remitting one month's compensation amount. The company reserves the right to terminate the services of contract appointee who fails to show satisfactory performance or even without assigning any reasons by giving one month's notice at any time during the contract period.

# Age and eligibility criteria
