

6. No claim for any service benefit like, PF, Pension, Gratuity, medical Allowance, Seniority, Promotion etc..
7. Candidates must be registered with Uttar Pradesh Medical Council or MCI before joining the post for the posts A, B & C. For post D registration certificate of enrolment on the Central Register of Indian System of Medicine or State Register of Indian System Medicine.
8. The candidate who is in Government Service should submit "No Objection Certificate" from the employer at the time of interview.

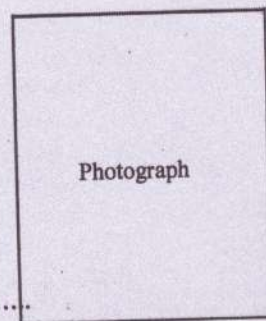
