

## ENGAGEMENT NOTICE

Applications are invited from women candidates for engagement/nomination for the post of Mahila Police Volunteer (MPVs) who will act as a link between police and the community and facilitate women in distress on the basis of monthly honorarium @ 1000/- per month under scheme of Central Government.

Candidates those who are permanent residents of the concerned PS/OP/TOP/Municipal Council Area/ Gram Panchayet/Ward office under West Tripura District are to be preferred.

Total number of posts under West Tripura District - 250.

Required Training will be given to the MPVs. Initial Term of an MPV will be for 2(two) years and will be reviewed every 6(six) month. MPV may be terminated based on review of her performance.

### Eligibility Criteria :-


1. Mahila Police Volunteer (MPV) should be a female and one MPV will be selected from each Gram Panchayet/Ward.
2. MPV should not be less than 21 years age.
3. The incumbent must possess at least 12<sup>th</sup> pass certificate.
4. She should be from the same geographical area and conversant with the local dialect.
5. She must not have been convicted of imprisonment for the violation of any criminal law.
6. No Criminal Proceedings must have been instituted against her.
7. She should not be a member of any political party.
8. Selected candidate will have to submit a self declaration that she has no criminal proceeding against her and she is not affiliated to any political party.

Application should be submitted **between the dates 10<sup>th</sup> January, 2020 to 10<sup>th</sup> February, 2020**. No application will be received after due date & time.
