ADVERTISEMENT

In pursuant to Hon'ble High Court Judgment and Order in Writ Appeal-18(AP)2018 Dated 27.03.2019 of WP(C)No.609(AP) 2017, Online applications are invited from citizens of India for filling up of **63(sixty three) posts of Junior Engineer (Civil)** under the Rural Works Department, Govt. of Arunachal Pradesh in the pay of PB-2 Rs.9300-34800 & GP Rs. 4200/- PM plus other allowances as admissible to Arunachal Pradesh Govt. employees Group-B (Non-ministerial) from time to time. Vacancy position is subject to variation. Any vacancy/post(s) if received from other engineering departments will be included and notified before the written examination is held. **Out of 63(sixty three) posts, 52 posts are reserved for APST candidates of which 2(two) posts are reserved for physically handicapped candidates and 11 (eleven) posts unreserved (Open competition).**

1. AGE:-

The candidates must have attained 18 years of age and should not be more than 32 years of age as on **15-04-2020**. However, the upper age limit is relaxable in accordance with the orders issued by the Govt. of Arunachal Pradesh from time to time. **ONE TIME RELAXATION OF UPPER AGE LIMIT** will be given to those eligible candidates who had been issued Admit Card in respect of the Advertisement issued by the Rural Works Department vide No. RWD/Cord/Estt./Advt-582/2017-18 dated 22<sup>nd</sup> February, 2017 vide Govt. Notification No. AR-20/2018 Dated 23<sup>rd</sup> August, 2018. **Those candidates who have applied earlier and issued Admit Card will have to login to [www.appsconline.in](http://www.appsconline.in) and upload their photograph and signature alongwith the details. And they are not required to pay examination fees. The details of such candidates shall be uploaded in website [www.appsconline.in](http://www.appsconline.in)**

2. EDUCATIONAL QUALIFICATION :-

The candidate must have completed **3(three) years Diploma in Civil Engineering/Agricultural Engineering/Bachelor degree in Civil Engineering/Agricultural Engineering from a recognized University/Institution.**

However, students who have already appeared in final examination of the qualifying diploma/degree course and awaiting result shall also be eligible to apply. Such candidates who are declared to have qualified by the Commission in the written competitive examination will have to produce original certificate/mark sheets of passing their degree/diploma examination issued by the Registrar/Assistant Registrar/ Controller of examination/Vice Chancellor of the concerned University will only be accepted by the Commission on or before the date of Interview/Viva-voce. Without the original certificate/ mark sheet they shall not be allowed to appear in the Viva-voce.

### 3. METHOD OF SELECTION:-

The eligible candidate will have to appear in written examination in the following subjects followed by Viva-voce/Interview to be conducted by the Arunachal Pradesh Public Service Commission at Itanagar on the basis of which selection will be finalized.

(i)	<u>Compulsory paper</u>	
	(a) General English	Maximum marks = 100
	(b) General Knowledge	Maximum marks = 100
(ii)	Technical paper (Civil Engineering)	Maximum marks = 100
(iii)	Interview/Personality test	Maximum marks = 40
		<b><u>Total marks = 340</u></b>

The candidate who secured a minimum of 33% or more marks in each written examination papers and 45% or more marks out of aggregate total marks in the written examination papers shall be eligible for Interview/Viva-voce test. On the other hand, it will further mean that selection for Viva-voce shall be based on the aggregate total marks secured in the written examination papers and subject to ratio of 1:3. The candidates securing less than 33 % of marks in any of written examination paper shall not be eligible for appearing in the Viva-voce.

**NOTE:** The Commission will adopt Recruitment Test(Objective type) before the written examination. Recruitment Test will consist of 100 Objective Type Questions on Technical paper(Civil Engineering) as per syllabus.

4. **FEE:** Candidates are required to pay fee of Rs.100 for APST candidates and Rs.160 for Non-APST candidates through online.
5. **HOW TO APPLY:** Candidates are required to apply online only using Website [www.appsconline.in](http://www.appsconline.in). Brief instruction for filling up online application is available on the above mentioned Website.

Scanned copies of the following documents/information are to be attached/uploaded:-

- (i) Scanned Signature of the candidate on white paper with black ink pen (20-60 kb in jpg format).
- (ii) latest/Recent passport size photo (40-100 kb in jpg).

**NOTE :** CANDIDATES SHOULD NOT USE MOBILE PHONE TO APPLY ONLINE AND SHOULD CAREFULLY READ AND UNDERSTAND BROWSER INFORMATION BEFORE APPLYING ONLINE.

### IMPORTANT

(i) The candidates applying for the examination should ensure that they fulfill all the eligibility conditions for admission to the examination. Their admission to the examination at all stages of examination for which they are admitted by the Commission viz written examination and interview/viva-voce test will be purely provisional subject to their fulfilling the prescribed eligibility conditions. If, on verification at any time before or after the written examination and interview/viva-voce test, it is found that they do not fulfill any of the eligibility conditions, their candidature of the examination will be cancelled by the Commission.


(ii) The eligible candidates shall be issued e-Admit card before commencement of the written examination. The e-Admit card will be made available on the AP PSC website for downloading by candidates. No admission certificate will be sent by post. For downloading the e-Admit card, the candidates must have his/her parameters like registration ID and date of birth or Roll No. (if received and date of birth or father's name) available with his/her.

6. The candidates who have been declared qualified in written examination will have to submit Xerox copies of the following documents/information to the Commission before the interview date.

- (i) Recent Passport size Photograph
- (ii) Matriculation certificate issued by Board/University for proof of date of birth
- (iii) Class XII Certificate with Marksheet
- (iv) Diploma Certificate with Marksheet issued by the Registrar/Assistant Registrar/Controller of Examination/Vice Chancellor of the concerned University to ascertain educational qualification
- (v) APST Certificate
- (vi) Any other documents as may be relevant
- (vii) Intimation letter to HoD for those who are in regular Govt. Service

**QUALIFIED** candidates will have to produce the above mentioned **Certificate/Documents and Marksheets** in **ORIGINAL** at the time of interview/viva-voce.

7. **LAST DATE FOR SUBMISSION OF APPLICATIONS:** The Online applications shall be accepted upto **15-04-2020** till 4 P.M. after which the link will be disabled.
