Engagement of Senior Residents will initially be for a period of one year and may be renewed/extended on yearly basis for a total period of 3 years including the initial one year, subject to satisfactory performance. Further the panel may remain valid for a period of three months from date of publication of result and may be cancelled/invalidated earlier without assigning any reason. **Candidates who have completed 3 years tenure as Senior Resident in Govt. Institution need not to apply. Senior Resident who are already working in any Govt. Institution shall apply through proper channel. The total period, however, should not exceed the maximum period of three years.**

a. Essential Educational qualification as on 11.03.2020 for All the Departments/Specialties

i. Medical PG Degree in concerned specialty/Department from a recognized Medical Institution.

Medical Diploma in concerned specialty/Department from a recognized Medical Institution with 2 years experience from a Medical Institution.

- ii. MCI/State MC Registration
- iii. Candidates on bond are not eligible.
- **iv.** Candidates need to provide Bond clearance certificate from Appointing Authority which have completed compulsory post PG Bond Service.

<u>Age</u>: Not exceeding 37 years as on **11.03.2020**. (Relaxation for SC/ST/OBC/PWD as per rules).

- **b.** <u>Emoluments:</u> i. Senior Resident under Residency Scheme: Consolidated remuneration of Rs. 101000/- per month. The consolidated remuneration may stand revised by 2.50% after every one year (No other allowances would be payable).
 - **ii.** Senior Resident against GDMO: Consolidated remuneration of Rs. 101000/- per month (No other allowances would be payable).

NOTE-1: At the time of Interview the candidates should bring along with them Original plus Attested copies of MCI/State MC Registration, Educational qualifications certificates/mark sheets from Matriculation or equivalent onwards, Experience certificate (if any), Proof of Age (Matriculation certificate/Admit Card), Caste certificate (in case of OBC candidate, updated OBC certificate in Govt. of India Format to be submitted), Disability Certificate from Competent Authority, and 2 recent passport size photographs.

CRITERIA OF INCOME & ASSETS (For Economically Weaker Section or EWS):

Persons who are not covered under the scheme of reservation for SCs, STs and OBCs and whose family has gross annual income below **Rs. 8.00 lakh (Rupees eight lakh only)** are to be identified as EWSs for the benefit of reservation. Income shall also include income from all sources i.e. salary, agriculture, business, profession, etc. for the financial year prior to the year of application.

Also persons whose family owns or possesses any of the following assets shall be excluded from being identified as EWS, irrespective of the family income:-

- i. 5 acres of agricultural land and above;
- ii. Residential flat of 1000 sq.ft. and above;
- iii. Residential plot of 100 sq. yards and above in notified municipalities;
- iv. Residential plot of 200 sq. yards and above in areas other than the notified municipalities.

The property held by a "Family" in different locations or different places/cities would be clubbed while applying the land or property holding test to determine EWS status.

The term **"Family"** for this purpose will include the person who seeks benefit of reservation, his/her parents and siblings below the age of 18 years as also his/her spouse and children below the age of 18 years.

INCOME AND ASSET CERTIFICATE ISSUING AUTHORITY AND VERIFICATION OF CERTIFICATE:

The benefit of reservation under EWS can be availed upon production of an Income and Asset Certificate issued by a Competent Authority. The Income and Asset Certificate issued by any one of the following authorities in prescribed format as given in **Annexure-I** shall only be accepted as proof of candidates claim as belonging to EWS:-

- i. District Magistrate/ Additional District Magistrate/Collector/Deputy Commissioner/ Additional Deputy Commissioner/1st Class Stipendary Magistrate/Sub-Divisional Magistrate/Taluka Magistrate/Executive Magistrate/Extra Assistant Commissioner.
- ii. Chief Presidency Magistrate/Additional Chief Presidency Magistrate/Presidency Magistrate.
- iii. Revenue Officer not below the rank of Tehsildar and
- iv. Sub-Divisional Officer or the area the candidate and/or his family normally resides.

NOTE-2: THE CANDIDATES SHOULD REPORT AT 09 AM FOR VERIFICATION OF DOCUMENTS AT ADMINSTRATIVE BLOCK OF ESI PGIMSR AND ESIC HOSPITAL & ODC (EZ), JOKA Terms & Conditions:

- 1. Private practice of any kind will not be allowed.
- 2. No TA/DA will be admissible for joining purpose.
- 3. Candidate selected for engagement will have to execute a contract on a stamp paper of Rs. 100/-. The original contract will be with the hospital and its copy will be with candidate. Cost of the stamp paper will be borne by the candidate.
- 4. On engagement Senior Residents will be required to deposit security of Rs. 32000/- (Rupees thirty two thousand only) through Demand Draft in favour of ESI Fund Account No. 1 at the time of joining, which is refundable only after completion of engagement period and on production of **"No dues certificate".**
- 5. Residential accommodation will be provided to selected Senior Residents under Residency Scheme.
- 6. Accommodation/quarter will be provided subject to availability. If provided the ESIC Hospital, Joka will not allow any House Rent Allowance (HRA). In case of non acceptance of quarter facilities by him/her inspite of availability of the quarter the ESIC Hospital, Joka authority can deduct admissible HRA from his/her salary.
