NOTE:

- The number of candidates advertised is only approximate and is liable for modification including reduction/increase with reference to vacancy position at any time before finalisation of selection.
- The candidate on their selection will be placed on three months training period in the level 2 of workmen pay matrix and they should be preferred to serve anywhere in Tamil Nadu. After successful completion of training period they will be appointed as Field Assistant.
- Notwithstanding anything contained in any orders/instructions/ guidelines in force relating to request transfer of Officers/Workmen of the TANGEDCO/TANTRANSCO, for effecting maintenance, improving of administration, to ensure utmost consumer satisfaction, and in public interest, that the candidates appointed by Direct Recruitment to this post, until completion of five years, shall not be eligible to make any application requesting transfer to any other circle/office under the control of any other appointing authority and until completion of three years, shall not be eligible to make such application within the circle/office under the control of the same appointing authority.
- All eligible candidates including the candidates sponsored by the Employment Exchange, those who have registered in the Employment Exchange, candidates who have completed ITI Apprentice in erstwhile TNEB/ TANGEDCO/ TANTRANSCO and Open Market candidates shall apply through online for competing in the selection process. Applying for the post through online and attending the physical test and written examination alone is not a guarantee for appointment or selection to the post.

4. ELEGIBLTY CRITERIA:

A. AGE (as on 01.07.2019):

Note:-

(i) For Differently Abled Persons:

Differently Abled Persons are eligible for age concession upto 10 years over and above the maximum age limit prescribed above.

(ii) For Ex-servicemen:

- a. The maximum age limit is 53 Years for the Applicants who belong to SCs, SC(A)s, STs, MBCs/DCs, BCs and BCMs.
- b. The maximum age limit is 48 years for "others" (i.e.) Applicants not belonging to any of the above said categories.
- c. The above concession will not apply to the Applicants those who have already been recruited to any class or service or category.

(iii) Apprenticeship:

In respect of Apprenticeship candidates, age relaxation will be allowed to the extent of the actual period of apprenticeship training.

(iv) However the upper age limit prescribed in these Regulations shall not apply :-

- a. to the appointment of a candidate belonging to any of the Scheduled Castes, Scheduled Tribes, Backward Classes, Most Backward Classes and Denotified Communities or destitute widows of all castes to a category or post included in a class of service for which the Regulations prescribe a qualification lower than a degree of any University recognized by the University Grants Commission, if such candidate possesses a general educational qualification which is higher than the minimum general educational qualification (ie., (1) A pass in the Secondary School Leaving Certificate Examination with eligibility for admission to college course of studies in the Universities in this State; or (2) A pass in the Secondary School Leaving Certificate Examination of this State) and he is otherwise qualified for appointment: or
- b. to the appointment to a post included in a class of service of a candidate belonging to any of the Scheduled Castes, Scheduled Tribes, Backward Classes, Most Backward 105 Classes and Denotified Communities or destitute widows of all castes who holds a degree of any University recognized by University Grants Commission, if the degree he/she holds is not lower than the degree, if any, prescribed for appointment to such post and if he/she is otherwise qualified for appointment.

Explanation: "No upper age limit" shall mean that the candidates should not have completed 58 years of age either on the date of Notification or at the time of selection / appointment to the post.

Candidates should possess the following qualification

i. Knowledge in Tamil:-

Candidates should possess an adequate knowledge of the official language of the State, namely Tamil, on the date of this notification as per (Per.) FB TANGEDCO Proceedings No.42 (Secretariat Branch) Dated 28.11.2019.

Explanation :

For this purpose, a person shall be deemed to possess an adequate knowledge of Tamil, if:-

(i) in the case of a post for which Educational Qualification is the Minimum General Educational Qualification and above, he/she should have passed the Secondary School Leaving Certificate Public Examination or its equivalent examination with Tamil as one of the languages, or studied the High School course in Tamil Medium and passed the Secondary School Leaving Certificate Public Examination or its equivalent examination in Tamil Medium;

(ii) in the case of post for which the educational qualification prescribed is below S.S.L.C., he has studied in Tamil Medium or passed Tamil as one of the languages in those standards or in any higher standards upto the level mentioned in Explanation (i) above.

5. GENERAL INFORMATION:

- A. The Rule of reservation of appointments is applicable to this post and the distribution of vacancies will be as per rule in force.
- B. Persons who belong to the State of Tamil Nadu alone, who belong to one of the Communities specified in **Annexure-III** shall be treated as persons who belong to one such communities.
- C. A minimum of thirty percent of all vacancies which are to be filled through direct recruitment shall be set apart for woman candidates. If no qualified and suitable woman candidates are available for selection against the vacancies reserved for them, those vacancies will be filled by male candidates belonging to the respective communal categories.
- D. <u>**CERTIFICATE OF PHYSICAL FITNESS**</u>: Candidates selected for appointment to the post will be required to produce a certificate of physical fitness from the Medical Officer of rank as stipulated by TANGEDCO.
- E. The Differently Abled persons should produce a copy of certificate of physical fitness specifying the nature of physical disability and the degree of disability based on the norms laid down, from the Medical Board to the effect that his/her disability will not render him/her incapable of efficiently discharging the duties attached to the post to which he/she has been selected before appointment when called for by Tamil Nadu Generation and Distribution Corporation.
- F. As per the G.O.(Ms).No.56, Energy (B2) Department, dated 26.07.2019 the following category of persons with benchmark disability are not eligible to apply for the post of Field Assistant (Trainee):
 - i) ASD Autism Spectrum Disorder
 - ii) CP Cerebral palsy
 - iii) DB Deaf Blindness
 - iv) HI Hearing Impaired

- v) MD Multiple Disability
- vi) MI Mentally ill (Schizophrenia, BPAD Bipolar Affective Disorder, OCD – Obsessive Disorder)
- vii) Mud Muscular Dystrophy
- viii) SLD Specific Learning Disability
- ix) VI Visually impaired
- x) ID Intellectual Disability

*The above eligibility/non-eligibility is subject to modification as per the clarification to be received from the Government of Tamil Nadu regard to Differently Abled Persons.

- G. Reservation of appointment to "Destitute Widows" and "Ex-servicemen" **will apply to this recruitment.** Provided that in all cases, an Ex-Serviceman once recruited to a post in any service or class or category, cannot claim the concession of being called an Ex-Serviceman for his further recruitment.
- H. Even after filling up of the posts reserved for SC Arunthathiyars on preferential basis, if more number of qualified Arunthathiyars are available, they shall be entitled to compete with the Scheduled Castes other than Arunthathiyars in the inter-se merit among them and if any posts reserved for Arunthathiyars remain unfilled for want of adequate number of qualified candidates, it shall be filled up by Scheduled Castes other than Arunthathiyars.
- I. The selection for appointment to the above said posts is purely provisional subject to final orders on pending Writ Petitions or Writ Appeals, if any, filed in Madras High Court and Madurai Bench of Madras High Court.
- J. Correct and true information regarding arrest, convictions / debarment / disqualification by any recruiting agency, criminal or any disciplinary proceedings initiated or finalised, participation in agitation or any Political Organisation, candidature in election for Parliament / State Legislature / Local Bodies etc, if any, should also be furnished to the TANGEDCO at the time of application i.e. the details thereof, originals of the judgment of Acquittals, order/ or G.O. Dropping further action in Departmental proceedings or any document that may prove the suitability of such candidates for a Government appointment in such cases must be produced at the stage / time of certificate verification. Any of the above said events that occur after submission of application and before actual appointment shall also be informed to the TANGEDCO. Failure to inform will entail suitable penal action as decided by the TANGEDCO.
- K. The original certificate for any claim relating to the selection should be produced when called for. Any claim received thereafter will not be taken into consideration.
- L. Evidence for claims made in the online application should be uploaded / submitted in time when called for the documents. Any subsequent claim made thereafter on submission of online application will not be entertained. Failure to submit the documents within the stipulated time limit will entail rejection of the Application.
- M. Applications containing wrong claims relating to other basic qualifications / eligibility age/ category of reservation / educational qualification will be liable for rejection, at any stage of the Selection Process and necessary criminal action will be taken as per the rules and regulation of the TANGEDCO.

- N. Regarding determination of community and reservation in employment for third gender, refer G.O.(Ms).No. 90, Social Welfare and Nutritious Meal Programme [SW8(2)] Department, dated 22.12.2017.
- O. <u>NO OBJECTION CERTIFICATE / INFORMATION TO THE EMPLOYER</u> Persons who are in service should apply for this examination only after informing the appointing authority 'No Objection Certificate' obtained from appropriate authority shall be produced at the time of Certificate verification, failing which, the application will be rejected. Any violation of this instruction will be liable for / end in rejection of application and forfeit his/her candidature. Person who gets employment in Government Services after the submission of their applications should also produce the No Objection Certificate (as per the format specified at Annexure-IX) at the time of Certificate verification.
- P. Words of Masculine Gender in these instructions should wherever the context so requires be taken to include Female Gender.
- Q. TANGEDCO reserves its right to postpone/cancel the recruitment process at any stage without assigning any reasons thereof.

6. PROCEDURE OF SELECTION:

A. SELECTION METHOD:

(i) Applying for the post through online and attending the Physical Test and Written Examination is not a guarantee for appointment or selection to the post.

(ii) All candidates including the candidates sponsored by the Employment Exchange, those who have completed ITI apprenticeship training in TANGEDCO/ TANTRANSCO/ TNEB and open market upon their eligibility as per qualification, age and other criteria have to apply through ONLINE to appear in the Physical Test.

(iii) The details of Physical Test to be conducted is provided as Annexure- II

(iv) After Certificate verification and physical test, the candidates who passed the Physical test alone will be permitted to appear in the Competitive Written Examination and the candidates who do not pass the Certificate verification and Physical test will not be permitted to appear in the Competitive Written Examination and further selection process. The competitive written examination shall be of objective type questions.

(v) After verification of the original certificates, physical test and written examination, the eligible candidates will be selected as per eligibility, merit of the marks in Competitive Written Examination and rule of reservation (respective turn in the Communal roster).

a. Provided that, when a candidate earmarked in the communal roster against the vacancy reserved for Scheduled Castes, Scheduled Tribes, Most Backward Classes/ Denotified Communities, Backward Classes, Backward Class Muslims or General Turn or in the case of priority or preferential Quota, found to be ineligible or not joined, such turn shall be filled from the respective category and in accordance to the merit of marks.

- b. Provided also that, the candidates must have full eligibility and such candidates appointed shall be placed below all the candidates earmarked in the communal roster.
- c. Provided also that, even thereafter if the vacancy remains unfilled due to nonavailability of candidates, the process stated under (v)a and (v)b above may be repeated until the vacancy is filled or until there is no availability of required eligible candidates or as decided by the Competent Authority at that point of time.

(vi) Provided other things being equal among candidates, preference for selection will be given to apprenticeship holders who have undergone apprenticeship training in TANGEDCO/TANTRANSCO/TNEB (prior to the date of notification).

E) RANKING METHODOLOGY:

The following methodology will be followed for arriving ranking for Direct Recruitment to the post of Field Assistant (Trainee) :-

- 1. Ranking will be based on the merit of marks obtained by the candidates in the OMR Examination.
- 2. If more than one candidate have scored same marks then the candidates with the lesser wrong answer will be placed higher in the ranking. The questions which were left unanswered will not be taken into account as wrong answer.
- 3. In case, if one or more candidates having same marks and with same number of wrong answer, then the candidate who is senior as per his/her date of birth will be placed higher in the rank.
- 4. In case, if one or more candidates having same marks, with same number of wrong answer and also with same date of birth, then the candidate who have submitted online application earlier will be placed higher in the ranking.
- 5. Even after the above if one or more candidates having equal footing then ranking will be arrived as per the alphabetical order of names.

7. CENTRES FOR EXAMINATION:

The centre for physical test and examination will be updated in the TANGEDCO website and will be informed to the candidates in their registered mail id.

Note: The TANGEDCO reserves the right to increase/decrease the number of centres and to re-allot the candidates.

9. CONCESSIONS:

Persons claiming concessions in the matter of age and/or fee allowed has to produce evidence for such claim when called for, otherwise his / her application will be liable for rejection.

10. HOW TO APPLY:

- Candidate should apply only through Online in the TANGEDCO's Website <u>www.tangedco.gov.in</u>. In the website the candidate can go to the online application portal by clicking the link.
- 2) The candidate should use a valid e-mail id and a valid mobile number for registration in online application. This email id and mobile number must be maintained active, as all the communications to the candidates from TANGEDCO will be sent only to the registered email id and mobile number.
- 3) The candidate must keep ready the details of Marks, Percentage/CGPA, Certificate Numbers, Year of Passing, Board/Institution details etc., in their hands before applying through online.
- Before applying, the candidates should have the following items to be ready in CD or DVD or Pen drive as per the convenience of the candidates.

- iv) Scanned copy of the certificate for Differently abled (if applicable) in **PDF** format only.

11. APPLYING ONLINE:

- 1. Candidates are first required to log on to the TANGEDCO's Website <u>www.tangedco.gov.in</u>. In the website the candidate can go to the Online application portal by clicking the link.
- 2. Follow the procedure given in the Guidelines to the candidates for applying in Online.
- 3. Applying through online have the following major procedures
 - a) One Time User Registration.
 - b) Candidate Profile updation which includes various sections like Personal Information, Educational Qualifications, Apprentice Training & Experiences and Declaration section along with necessary relevant upload of scanned copy of documents.
 - c) Apply for the post.
 - d) Payment of Examination fees.
 - e) Download of Application form.

Note: The candidates must keep a copy of the application submitted by them and produce the same as and when requested by the TANGEDCO during selection process.

- 4. After the candidate completes the One Time Registration, an USER ID with Password will be generated. The User ID & Password has to be kept confidential and do not disclose it to anyone.
- 5. This USER ID can be used for log on into the application portal for applying for various posts if the candidates are eligible for that post after updating the relevant profile information.

6. Candidates are required to upload their photograph, signature, and left hand thumb impression as per the specifications given in the Guidelines for scanning and upload of photograph, signature, and left hand thumb impression. If the candidate is coming under differently abled category and unable to take left hand thumb impression, then the candidate can take Right hand thumb impression. **An online application uploaded without photograph, signature, and thumb impression will be rejected.**

Note: Candidate who have One Time Registration User ID and Password have to apply separately for all Notifications. One Time Registration will not be considered as an application for any post.

11.(i) MODE OF FEE PAYMENT:

- 1. The candidates can make payments through Bank Chalan, Net Banking, Payment Gateway and Debit/Credit card.
- 2. For mode of payment through chalan, the candidates have to select either Canara Bank or Indian Bank or Indian Overseas Bank.
- Click "Download Challan" option. System will generate the payment challan which the candidates need to take print out and go to the nearest branch of Indian bank or Canara bank as the case may be, to make the payment.
- 4. Collect the Candidate and TANGEDCO copy of the fee payment challan from the bank branch. Please check that **Bank reference No, TANGEDCO acknowledgement number**, Bank Branch code, and Deposit Date have been noted in the challan and is properly signed by the branch authorities. TANGEDCO copy need not be uploaded or submitted to TANGEDCO, but to be kept safe and to be produced when required.

11.(ii) PRINT OPTION:

- 1. After submitting the application, candidates can print/save their application in PDF format and should produce the same as and when called for.
- 2. After logon to the application portal using User ID and password, Candidate can download their application and print it.
- 3. Candidates need not send the printout of the online application or any other supporting documents to the TANGEDCO. The certificates and the other documents along with application will be verified only at the time of certificate verification of the eligible candidates which will be intimated later.

Note:

- (i) Candidates are advised in their own interest to apply on-line much before the closing date and not to wait till the last date for depositing the fee/ intimation charges to avoid the possibility of disconnection/inability/failure to log on the TANGEDCO's website on account of heavy load on internet/website jam.

- d) If the photocopies of all related documents are not uploaded as well as and when asked to do so.
- e) If a candidate fraudulently claim SC/SCA/ST/BCO/BCM/MBC/DC/Exs./DW/ Differently Abled persons/Priority status.
- f) In case the candidate is found using unfair means or adopting any malpractice at any stage of selection process.

13. OTHER IMPORTANT INSTRUCTIONS

a. <u>Applicants should ensure their eligibility for the post</u>: The applicants applying for the post should go through all instructions carefully and ensure that they fulfil all eligibility conditions and furnish all the required particulars in the online application. Claims made at later stages, after submission of online application will not be entertained. Their admission to all stages of the physical test and examination will be purely provisional subject to satisfaction of the eligibility conditions. Mere issue of memo of admission to the applicant will not imply that his/her candidature has been fully cleared by the TANGEDCO.

- b. The certificates should be submitted when called for certificate verification by the TANGEDCO. If on verification at any time before or after the written examination, it is found that they do not fulfill any of the eligibility conditions; their candidature for the examination will be cancelled by the TANGEDCO.

The details will be made available on the TANGEDCO website. Applicants will be informed of the above fact only through SMS and e-mail.

f. Mobile Phones and other Articles Banned:

- (i) Candidates are not allowed to bring Pager, Cellular Phone, Calculator, Memory Notes and books etc. or any other Electronic device or Recording Device either as separate piece or part of something used by the candidate such as Watch or Ring inside the Examination Hall.
- (ii) If they are found to be in possession of any such thing or instrument they will not be allowed to write the examination further, besides invalidation of answer paper and / or debarment. If it is considered necessary they will be subjected for a physical search including frisking on the spot.
- (iii) Do not bring into the Examination Hall any article such as books, notes, loose sheets, mathematical and drawing instruments, Log Tables, stencils of maps, slide rules, Text Books, rough sheets etc. except the permitted writing material i.e. pen. No colour pen or pencil must be used.
- (iv) Candidates are advised in their own interest not to bring any of the banned items including Mobile Phones / Pagers to the venue of the examination, as arrangements for safekeeping cannot be assured.

- h. Conduct in Examination Hall: No candidate should misbehave in any manner or create a disorderly scene in the Examination Hall or harass the staff employed by the TANGEDCO for the conduct of the examination. Any such misconduct will be severely viewed & penalised.
- i. The applicants while applying for the examination should furnish the details of equivalence of qualification declared in the form of Government Order issued prior to the date of this notification, if any, and produce the same during certificate verification or when called for by TANGEDCO, failing which their application will be rejected. The Government Orders issued regarding equivalence of prescribed qualification after the date of this notification will not be accepted.
- j. After notification during the process of recruitment till completion of the entire examination process, no information under Right to Information Act would be furnished.
- k. The details regarding applications etc. pertaining to this Direct Recruitment will be only made available to candidates under R.T.I. etc. within 6 months from the date of publication of results. Any application/request beyond the period of 6 months will not be entertained.

ANNEXURE -II

PHYSICAL TEST FOR THE POST OF FIELD ASSISTANT (TRAINEE)

i) The Physical Test shall contain 3 activities as detailed below:-

a) Activity - i

POLE CLIMBING AND CROSS ARM FIXING - The candidate has to properly wear the belt rope, have to climb the 9 meters PSC pole (ie., 30 feet pole) and have to carry along with him one end of rope in which the other end will be kept tied with 3 - phase cross arm. The candidate has to fix the wooden support for foot rest, have to tie the belt rope with the pole for safety purpose and have to fix the 3 - Phase Cross Arm at the top of the pole securely and he should have to safely climb down. The Cross Arm should be fixed around one feet from the top of the pole. The above process should be completed within 8 minutes in one chance.

<u>b) Activity - ii</u>

Plaiting of rope with AAAC 7/3.15 mm conductor, marking and fixing the conductor on creeper, binding and fixing in the HT Disc and inserting the M.Pin. The number of rotations to be made while binding should not be less than 20 rounds. The above process should be completed within 2 minutes in one chance.

<u>c) Activity – iii</u>

The candidate has to successfully Lift and Carry 3 Nos. of 3 1/2 feet V-Cross Arm (around 35 kg) for a distance of 100 meters in one minute in one chance without putting the weight down.

ii) Those who have not properly tied the belt rope will not be allowed for further participation in the physical test and such candidates will be deemed to be considered as failed in the physical test.

iii) The candidates should not use any device for climbing the pole.

iv) The candidate who successfully completes the first activity alone will be permitted for second activity and those who completes first and second activity alone will be permitted for third activity.

v) The candidates who have passed all the above activities alone will be permitted to appear in the Competitive Written Examination for further selection process.

vi) No points or marks or priority will be given in the written examination based on the performance in the above physical activities.

vii) No exemption will be provided to woman or Differently Abled Persons or any other persons who are unable to (or) refuse to perform the physical test and such candidates will be deemed to be considered as failed in the physical test.
