ADVERTISEMENT

Online applications are invited from the citizens of India for filling **up 69(sixty nine) posts of General Duty Medical Officer (Allopathy)**, under the Department of Health & Family Welfare, Govt. of Arunachal Pradesh in the Pay scale of PB- 3 Rs. 15,600-39,100/- Plus Grade pay of Rs. 5400/- P.M plus NPA as admissible under rule. Out of 69(sixty nine) posts, 55 (fifty five) posts are reserved for APST candidates,14(fourteen) posts are un-reserved and 3% of posts from 55 (fifty five) posts are reserved for Persons with Disabilities (PwD) candidates. The vacancy position is subject to variation.

(A) HOW TO APPLY:-

- (a) Before applying online Application for the post, candidate must mandatorily register themselves in **ONE TIME REGISTRATION (OTR)** (www.appsc.gov.in)
- (b) Candidates are required to apply online using the website www.appsc.gov.in. Detail instructions for One Time Registration (OTR) and Online Application are available on the above-mentioned website. The applicants are advised to submit only single application; however, if due to any unavoidable situation, if he/she submits another/multiple applications, then he/she must ensure that application with the higher Registration IDs (RID) is complete in all respect like applicants' details, , photograph, signature, Photo ID, fee etc. The applicants who are submitting multiple applications should note that only the applications with higher RID shall be entertained by the Commission and fee paid against one RID shall not be adjusted against any other RID.
- (C) Those who have already registered in OTR need not register again and they can directly log in to fill up online form using their user ID and password.

(B) ELIGIBILITY:-

- A recognized medical qualification included in the First or Second Schedule or Part-II of the Third Schedule (other than licentiate qualification) of the Indian Medical council Act, 1956. Holders of Educational qualification included in the Part-II of the Third Schedule should also fulfill the condition stipulated in sub-section (3) of the section (13) of the Indian Medical Council Act, 1956.
- The Candidates who may not have completed compulsory rotating internship are also eligible
 to apply for the written examination as the case may be provided that at the time of actual
 interview, they shall have to produce proof of successful completion of the compulsory
 internship.

(C) AGE LIMIT:-

Not exceeding 30 years as on 17/07/2020 (Relaxable for SC/ST candidates etc by 5 years in accordance with instructions issued by the State Government).

Candidates who is on internship after qualifying the requisite examination shall also be eligible. However, such candidates will be admitted to the examination, if otherwise eligible but their admission shall be deemed to be provisional and subject to cancellation, if they do not produce the proof of having completed internship which are required to be submitted to the Commission by the Candidates who qualify in Written part of the examination prior to interview/viva-voce. Their candidature will be finally accepted on production of PROOF OF HAVING PASSED THE QUALIFYING EXAMINATION IN ORIGINAL ON OR BEFORE THE DATE OF INTERVIEW TO BE FIXED BY THE COMMISSION FAILING WHICH THEY WILL NOT BE ALLOWED TO APPEAR IN THE INTERVIEW/VIVA-VOCE TEST. If due to non holding of convocation the degree certificate cannot be produced then marksheet issued by competent authority should be produced as proof of having passed the qualifying examination and for the candidates of recognized Autonomous Colleges. MARKSHEET/GRADE REPORT IN ORIGINAL, issued by the Controller / Dy. Controller / Assistant Controller / Chief Controller of the examination of such recognized autonomous colleges shall only be accepted.

The decision of the Commission as to the eligibility or otherwise of a candidate for admission to the examination shall be final and binding. No candidate shall be admitted to the Written Examination unless he/she holds a certificate of Admission from the Commission for that purpose.

(D) METHOD OF SELECTION:-

The eligible candidate will have to appear in written examination in the following subjects followed by Viva-Voce to be conducted by the Arunachal Pradesh Public Service Commission(APPSC) on the basis of which selection will be finalized.

Paper-I: 200 Marks (Objective Type)

- (i) General Medicine including Cardiology, Neurology, Dermatology and Psychiatry.
- (ii) Surgery including E.N.T. Ophthalmology, Traumatology and Orthopedics.

Paper-II: 200 Marks(Objective)

- (i) Pediatrics
- (ii) Gynecology and Obstetrics
- (iii) Preventive, Social and Community Medicine
- (2) VIVA-VOCE: 50 Marks
- (i) Personality test and general aptitude
- (ii) General Medical Subjects for M.O. (Allopathy)

The candidates who secure a minimum of 33% or more marks in each written examination papers and 45% of marks out of aggregate total marks in the written examination papers shall be eligible for viva-voce test. On the other hand, it will further mean that selection for viva-voce test shall be based on the aggregate total marks secured in the written examination papers and subject to ratio of 1:3. The candidates securing less than 33% of marks in any of the written examination paper shall not be eligible for appearing in the viva-voce test



(E) Scanned copies of following documents and information are to be uploaded.

(i) Signature of the candidate on white paper with black ink pen (20-60 kb in jpg format).

- (ii) Latest/Recent passport size photo (40-100 kb in jpg format).
- (F) The candidates who have been declared qualified in the written examination will have to submit Xerox copies of the following documents/information to the Commission before one week from the actual date of Interview.
- (i) Recent passport size photograph
- (ii) Self Attested Xerox copies of certificates and marksheets issued by the Assistant Registrar/Registrar/Controller of Examination/Vice-Chancellor of the concerned University to ascertain degree.
- iii. Self Attested Xerox copy of Matriculation Certificate for proof of age issued by the Board only will be accepted.
- iv. Self Attested Xerox copy of APST certificate and copy of PRC in case of General candidates.
- v. All the supporting documents submitted by the candidates must be self attested other wise the application will be rejected.
- vi. Self Attested Xerox copy of Arunachal Pradesh Medical Council Registration Certificate.
- vi. Persons with Disabilities (PwD) candidates should submit disability certificate obtained from State Medical Board. Such board should comprise a specialist of the particular category of disability for which the certificate is sought for, failing which such certificate will be rejected.

Qualified candidates will have to produce the above mentioned Certificates/Documents and marksheets in original at the time of interview, failing which he/she will not be allowed to appear in the interview.
